Dear City Solicitor Buffington:

The above referenced matter is presently scheduled for trial on April 2, 2012. As you may recall this case is an appeal of the Municipal Council's decision denying the Plaintiff's request for a special permit to construct a 141-unit condominium at 91 Hart Street.

Before proceeding to trial our client is interested in meeting once more with the Municipal Council to explore the possibility of a settlement. In prior meetings the Council had expressed a preference for the petitioner to obtain an alternative means of access for this project in addition to Hart Street. The Council's primary concern in its comments was traffic impact on Hart Street.

Our client has thoroughly investigated the possibility of providing alternative access and Hart Street is the only potential access to this site. Therefore our client is interested in proposing other concepts to minimize impacts from this development.

We respectfully suggest that it would be best for all parties involved to negotiate a settlement now rather than to have a trial and negotiate a settlement later as part of remand proceedings.

We are optimistic that with several new members on the Council there will be a renewed interest in exploring settlement options and resolving this case. This project, if approved, will be a positive development for the economy of the City.

Please advise as to the Council's position regarding the above request for a final meeting to explore the possibility of settlement in this matter.

Dear Mayor Hoye and Members of the Municipal Council:

As you know, a trash fee of \$73.00 per residential unit was passed by majority vote of the prior Municipal Council as part of the prior administration's final version of the FY2012 city budget. As you also know, the budget was based on receiving the revenues to be generated by this fee which was estimated to be in the vicinity of \$1,300,000.00.

When the new administration took over, an inquiry was made as to the mechanism of billing for and collecting this fee. It was then discovered that an ordinance needs to be passed that authorizes the collection of the fee. It is unclear to this office why such an ordinance was not proposed or passed as part of the FY2012 budget process.


As a housekeeping matter, an ordinance needs to be passed. My office has been working with the DPW Finance Team, members of the Assessor's Office, and other city officials to draft a final ordinance. We have also reviewed policies and procedures adopted by some other communities that have similar rate structures. We are working on a final ordinance which not only authorizes the fee but sets forth an abatement procedure. This proposed ordinance will be ready for your consideration at the January 31st meeting of the Municipal Council.

As the current budget is based on the collection of this fee, I would respectfully urge your prompt consideration and passage of such an ordinance. Thank you, as always, for allowing me to be of service to you.
