### MEMORANDUM OF AGREEMENT

# City of Taunton and Taunton Police Supervisory Personnel Association, MCOP Local 338, AFL-CIO (7/1/08 – 6/30/11 Collective Bargaining Agreement)

1. Percentage Wage Increases:

July 1, 2008: 0% July 1, 2009: 0% January 3, 2010: 1.5% July 1, 2010: 2.5%

2. Effective January 3, 2010, roll the following stipends into base pay, including for purposes of overtime, and delete these stipend provisions from the contract:

Hazardous Duty (Art. 30, sec 2) Defibrillator (Art. 30, sec 14) Clothing Allowance (Art. 6, sec 2) Cleaning Allowance (Art. 6, sec 4)

- 3. Effective January 3, 2010:
  - (a) Delete the longevity provision (Art. 21) in its entirety:
  - (b) Institute a 3-step wage structure:
    - 1. Step 1: 0 to three years in the Supervisors' bargaining unit current pay rate with the above four stipends rolled into base pay
    - 2. Step 2: after three years in the Supervisors' bargaining unit -5% increase
    - 3. Step 3: after six years in the Supervisors' bargaining unit -5% increase
  - (c) Any officer who ends up owing the City money because of giving up longevity will not be required to pay that amount back.
- 4. The parties shall meet to reopen negotiations for the economic items in this agreement if any group who negotiates with the Mayor gets more than a 4% across-the-board increase in three years.
- 5. The Union accepts City's communications policy as tentatively agreed to (attached).
- 6. The Union accepts City's proposed dental insurance change, effective July 1, 2010.

# MEMORANDUM OF AGREEMENT

This Memorandum of Agreement is entered into this \_\_\_\_\_\_ day of \_\_\_\_\_\_, 2010 by and between the City of Taunton and the Massachusetts Laborer's District Council, Local 1144 (C) Taunton Nursing Home Union. The purpose of this Memorandum of Agreement is to extend the Collective Bargaining Agreement between the parties, which expires on June 30, 2009. To the extent that this memorandum does not modify the Collective Bargaining Agreement, then said Collective Bargaining Agreement shall remain in full force and effect.

NOW THEREFORE, the parties, having bargained collectively pursuant to Chapter 150E of the General Laws do hereby agree to the following revisions/amendments/modifications to the Collective Bargaining Agreement which expires on June 30, 2009.

1. The contract will be extended for a period of three (3) years, July 1, 2009 through June 30, 2012, but steps and longevity to increase as required by existing CBA and this memorandum.

### 2. ARTICLE XIV-DIFFERENTIALS

Section 1: Add Language: Anyone working 50% or more of his/her shift after 3:00 p.m., shall receive a \$.50 differential after 3:00 p.m.

### 3. ARTICLE XXII-MISCELLANEOUS

Section 5-Add: The reimbursement will be made within sixty (60) days after showing proof of payment provided that proper documentation has been submitted to the business office and that it is acceptable to the City Auditor.

# 4. ARTICLE XXVII -PAYROLL & WAGES (New Article number)

1. Effective January 1, 2010 or at a date following, when all general government employees have agreed, employees will be required to enroll in direct deposit.

# 5. New: ARTICLE XXVII-Wages

FY '10 (Effective upon signing & approval) –	1.5%
FY'11 – July 1, 2010-June 30, 2011-	2%
FY'12 – July 1, 2011-June 30, 2012-	2%
