Chapter 19

SEWERS AND DRAINS

Sec 19-3.1. Procedure for the Assessment of Betterments For Laying of Common Sewers

Be it ordained by the Municipal Council of the City of Taunton as follows:

That Section 19-3.1 of the Revised Ordinances of the City of Taunton, as amended, is and hereby is further amended by adding the following:

Sec. 19-3.1 Procedure for the assessment of betterments for the laying of common sewers.

- a. All betterments shall be assessed against owners of property abutting a common sanitary sewer line pursuant to Chapter 80 of the General Laws of the Commonwealth of Massachusetts.
- b. All such betterment assessments shall be based upon a proportionate share of One Hundred (100%) percent of the costs permitted to be included in a betterment assessment pursuant to said Chapter 80 of the General Laws of the Commonwealth of Massachusetts, unless such formula shall violate the provisions of any state or federal law or regulation or the terms of any state or federal grant or the terms of any loan agreement reached between the City of Taunton and the Water Pollution Abatement Trust of the Commonwealth of Massachusetts pursuant to Chapter 29C of the General Laws of the Commonwealth of Massachusetts.

All ordinances or parts thereof inconsistent herewith are hereby repealed. This Ordinance shall become effective immediately upon passage.



RE: Traffic Conditions on Warner Blvd

Dear Members of the Counsel,

I write to you after several phone calls to different authorities who informed me the City was ordered to remove the existing speed limit signs on Warner Blvd quite some time ago. The state is requiring an engineering study of the speed on Warner Blvd prior to speed limit signs being posted.

As the Human Resource Manager of Saint-Gobain Performance Plastics, on Warner Blvd., I am greatly concerned about the safety of all who travel on Warner Blvd. As you should know, Warner Blvd. is a long strip of road with an infamous reputation for speeders and drag racing. There have been 2 fatalities in the late ninety's due to speeding.

I call to your attention the fact that the Blvd. is now even more populated than in the past but the speeding cars have not abated and seem to be more plentiful in the absence of warning signs and other deterrents. Two large housing developments have gone up with children of all ages who now play adjacent to the street. Our employees, and other employees nearby, often walk on the Blvd for exercise during work breaks and joggers use the strip as well. My office faces the street and I have been alarmed at the number of cars going at great speed. Your attention to this matter is needed immediately.

At Saint - Gobain we value the satiety of our employees and try to prevent accidents from happening. If you are not the proper authority, kindly advise to whom this concern should be addressed.

Please order an engineering speed study as soon as possible. Hopefully this will prevent future fatalities.
