

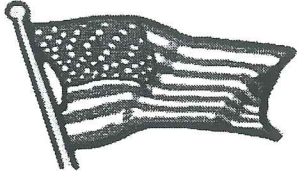
I was recently asked to provide the Council with a report regarding pothole claims. Please be advised that since November 1, 2013, this office has received a total of 64 claims for potholes. Of the 64 claims, 26 were denied, 15 were allowed, and 10 were referred to outside contractors who were performing work at the specified location and during the time of the claim. The remaining 13 claims are currently under review with the Law Department and the Department of Public Works. With regard to the claims that were allowed, the City of Taunton has paid out a total of \$5,867.60.

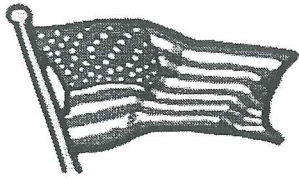
