

Unfortunately I was also there with my children (across from the second explosion) we were lucky enough to escape in one unharmed piece. I feel compelled to help my cousins at the same time do my best to pull the community together and we can come together for them as a whole.

I have everything in place as I have been in touch with Paul Allison from the Oakland Fire Station. He hosts the annual 5k run for MDA. He has offered to assist me the whole way, as well as physically help and guide the event the day of.

We intend to host the race Sunday, June 2<sup>nd</sup> 2013. The race will take place in the Myles Standish industrial park. The race will start at 11am. Head Start has already offered to donate their location for the start/end point. The route will consist of the following: Start at 62 Independence Dr., Left on Constitution Dr., Right onto John Hancock follow to end, Right onto Myles Standish, Right onto John Quincy Adams, Left onto Constitution Dr., Left onto Independence Dr., The race will end at the start point (62 Independence Dr.)
