**AN ORDINANCE**

**Chapter 18**

**POLICE**

**ARTICLE 1. IN GENERAL**

**Sec. 18-4. Constables.**

**Sec. 18-6. School traffic supervisors.**

*Be it ordained by the Municipal Council of the City of Taunton as follows:*

That Section 18-4 and Section 18-6 of the Revised Ordinances of the City of Taunton, as amended, be and hereby are further amended by adding thereto the following:

**Appointment of Constables:**

The municipal council may elect, in accordance with the General Laws, such constables as it deems proper, in accordance with the terms of this section, who shall first be duly sworn before entering upon the duties of their office. The municipal council shall, from time to time, promulgate such rules, regulations and procedures as it deems appropriate for the appointment of constables. (Appointment of constables, MGLA, c.41, Sec. 91-91B)

1. **Approval by chief of police.** The chief of police or designee shall investigate the reputation and character of the applicant and his or her fitness for the office, and make a recommendation to the Police and License Committee.
2. **Term.** The term of office shall be for three (3) years only from the date of appointment
3. **Removal.** The municipal council, after hearing, may remove a constable from office prior to the completion of said term for conduct unbecoming a constable, gross misconduct, or other just cause.
4. **Uniform and badge.** A constable shall have the permission of the chief of police and the committee on police and licenses to wear a uniform. However, to avoid confusion with members of the police department, the uniform shirt of said constable shall not be black or dark blue. In addition, a constable may wear an appropriate badge or patch that is clearly marked "Constable". In no case, however, will a constable use a badge or patch or article of clothing containing the word "police".
5. **Appointment of non-residents.** Nothing contained herein shall prohibit the municipal council from appointing as a constable an employee of the city who is not a resident of the city; provided, however, that no non-resident of the city shall be appointed as a constable unless the chief of police states in writing to the municipal council that the public safety and convenience of the citizens of the city would be injuriously affected if such non-resident applicant were not appointed.
6. **Fee.** The application fee shall be \$100.00.

Sec. 18-6. School traffic supervisors.

- (a) The chief of police may designate one or more of such constables as are also custodians employed by the school department of the city to be school traffic supervisors, who shall control pedestrian and vehicular traffic at such locations as the chief of police shall assign. Each such supervisor shall be equipped with a traffic belt, cap, coat badge and hat shield, furnished by the chief of police.
- (b) In addition to the foregoing, the municipal council shall appoint school traffic supervisors who shall be under the general supervision and direction of the chief of police.
- (c) The number of said school traffic supervisors may from time to time be determined by the municipal council.

**(d) The appointment process as outlined in Section 18.4 shall not apply to appointment of school traffic supervisors. There will be no fee for those applicants.**

All ordinances or parts thereof inconsistent herewith are hereby repealed. This Ordinance shall become effective immediately upon passage.

**Order for a first reading to be passed to a second reading**

Ordered That,

The sum of \$340,000.00 is appropriated in the form of a "Special Purpose Appropriation" for the following purposes: \$40,000.00 is hereby appropriated for the purpose of holding a special election on June 9, 2012 to determine whether the registered voters of Taunton approve a tribal gaming development proposed by the Mashpee Wampanoag Tribe, and all associated costs of said special election, and further that \$300,000.00 is hereby appropriated for the purpose of hiring outside consultants, outside legal counsel and other costs associated therewith, to determine the impact of the proposed tribal gaming development and to negotiate an intergovernmental agreement with the tribe, and, in furtherance of this special purpose appropriation, the Mayor is hereby authorized to enter into such agreements with such outside consultants and outside legal counsel upon such terms and conditions as the Mayor deems proper, expedient and in the best interests of the City.

**Order for a second reading to be ordained on a roll call vote**

Ordered That,

**\$230,000** is appropriated in addition to the \$6,300,000 previously appropriated for the purpose of financing the construction of various improvements to the City's water system, including without limitation the laying and relaying of water mains in various City streets, the replacement of City water meters and meter information collection system and the construction of well pumping appurtenances, chemical feed systems and water main replacements associated with the Dever Wells and including without limitation all costs thereof as defined in Section 1 of Chapter 29C of the General Laws; that to meet this appropriation the Treasurer with the approval of the Mayor is authorized to borrow **\$230,000** and issue bonds or notes therefor under Chapter 44 of the General Laws and/or Chapter 29C of the General Laws; that such bonds or notes shall be general obligations of the City unless the Treasurer with the approval of the Mayor determines that they should be issued as limited obligations and may be secured by local system revenues as defined in Section 1 of Chapter 29C; that the Treasurer with the approval of the Mayor is authorized to borrow all or a portion of such amount from the Massachusetts Water Pollution Abatement Trust established pursuant to Chapter 29C and in connection

therewith to enter into a loan agreement and/or a security agreement with the Trust and otherwise to contract with the Trust and the Department of Environmental Protection with respect to such loan and for any federal or state aid available for the project of for the financing thereof; and that the Mayor is authorized to enter into a project regulatory agreement with the Department of Environmental Protection, to expend all funds available for the project and to take any other action necessary to carry out the project.

**RE: Request for Purchase Scott Air Packs for the Department**

Dear Honorable Council Members;

I want to present to you my final analysis on the Fire Department's Budget for this current fiscal year. After polling all the members of the Fire Department I am happy to report that there should not be any additional retirements in fiscal year 2012. The Department's 2012 budget allotted \$305,000.00 to pay retirees for the combined sick, vacation, and personal time buyback. Only \$15,181.80 of this money was spent because we only had one firefighter retire this year. This leaves a surplus of \$289,818.20 in the current budget.


For these reason I am requesting that \$191,000.00 of excess funds available in my Salaries and Wage account be transferred into the Capital Account in order for the Department to purchase updated Scott Air Packs. As you know, these devices are a firefighter's primary defense from the dangers of a hazardous atmosphere. They are worn at every fire incident that our firefighters respond to such as structure fires, vehicle fires, hazardous material incidents, and carbon monoxide calls. They protect the respiratory systems of our firefighters from smoke, fire gases, hazardous chemicals, and airborne pathogens. Our current air packs were purchased in 1996 and have served the department well, but at 17 years old they are nearing the end of their service life.

Advances in technology have enhanced the safety features of today's air packs. The new style back frame is more streamlined allowing the user more comfort while helping to prevent fatigue. Items such as a visual 'heads up' display allow a firefighter to always be cognizant of how much air they have remaining in their tank. The addition of a drag rescue loop on the pack frames greatly enhances rescue efforts when dealing with an incapacitated firefighter in a burning building. Today's packs also contain 'black box' technology that tracks a firefighter's movements from the time the air valve is turned on.

I have spoken with Mayor Hoye and Budget Director Gil Enos about this issue. I believe this purchase to be the best investment the City can make in order to help protect our firefighters from the dangers they encounter daily. I ask you to please consider this transfer so that the men and women of the Taunton Fire Department can feel confident that they are protected by state of the art equipment while they perform their duties serving the citizens of the City.

Dear Honorable Councilors,

To follow up on Ms. Graves' response regarding betterments, we effectively are distributing the betterments onto the first and second quarter bills through our process of preliminary billing. When we set up the preliminary bills, we take 50% of the total billed for the previous tax year, divide it by 2 and that is the amount due for each on the first two payments. A portion of the previous year's total bill does include the betterment charge.

In speaking with our representative at WTI, we have the option to change the payments of the betterments to be due over the 3<sup>rd</sup> and 4<sup>th</sup> quarter due dates. This would still distribute the total obligation more evenly over the entire year. We will never be able to have four equal payments every year. We would still be in compliance with the statutes regarding the billing of betterments. Attached is a comparison of two current bills, as they were billed this fiscal year and how it would be if we were to split the betterment on the last two payments.



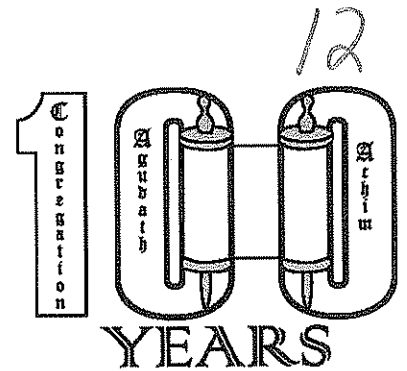

For this event, we have contacted the Taunton Police Dept. for detail work.



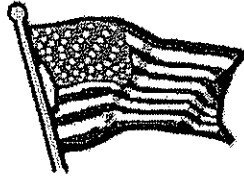
