Dear Ms. Blackwell:

Thank you for your letter regarding the double utility poles in the City of Taunton. I have forwarded the letter and list of poles to our Operations team, who are checking the poles to verify what transfers or removals are needed.

I believe that the Taunton City Council recognizes and appreciates the significant resources and coordination needed by all parties in addressing this issue. While the spreadsheet from Taunton Municipal Lighting Plant (TMLP) of pending pole removals and transfer was referenced, it may not have been reflective of the current status of attachments within the City of Taunton.

To that end, Verizon, TLMP and other entities attached to utility poles have joined the new pole status database (NJUNS), which is the on-line system used across the state to coordinate double pole activity. This system allows all pole owners and those with attachments to enter double pole information, and the system notifies the next party responsible for moving pole attachments when it is their turn to act.

We feel that the NJUNS system is the best and most consistent approach to addressing double poles, and we are exploring updates to the system to improve coordination and communication among those with attachments. We appreciate your interest in improving this process.

R.E: Gas Line to 25 Randall St. Taunton.

Dear sir/madam, I bought the above referenced property in 2011, and I wanted to switch from oil to gas, but Colombia Gas of Massachusetts told me that there was a 5 years moratorium on Randall St, and Department of Public Works confirmed that I had to wait for 4 years, knowing that one year had elapsed since Randall St was fixed.

This year, the moratorium would expire; however, last year, during the Summer months, they started fixing the sidewalk on Randall St. At that time, I went to the Department of Public Works again, and I asked if I could get the permission to do the gas line to the said location

I was told to wait until 2015. I asked if the new sidewalk being constructed was not going to push the moratorium for another 5 years, and was assured that it would not.

This year, in January, when Colombia Gas Of Massachusetts went to apply for permit to bring the gas line in, it was told to wait to apply in July, because the moratorium would expire at the end of June. In July, when the gas company applied again, it was told that there was another 5 years period moratorium on that sidewalk, and that now, we have to wait until 2019. The Department of Public Works advised me to write a letter to you, asking for a permission because there was nothing they could do for me

Considering that I waited 4 years to have the gas service delivered to the property, and that I did everything that I could to prevent further delays, I am hereby imploring you to grant me a special permit to have the Columbia Gas of Massachusetts bring the gas service to the property in reference.

According to Colombia Gas of Massachusetts, the gas service will be completed this year, if the permit is granted.
