

### Dear Mayor Hoye:

My name is Joseph DeCosta and my wife Donna and I reside at 37 Duffy Drive, in Taunton. We have lived on Duffy Drive for 42 years and have both been lifelong residents of the City of Taunton. My wife Donna is retired and I am planning retirement after recently reaching my 70th birthday. Our home on Duffy Drive is currently for sale and our goal is to spend the rest of our years on Cape Cod at our summer home in Centerville. In addition to our home on Duffy Drive, we own a separate vacant house lot that abuts the property at 37 Duffy Drive. We would like to sell that vacant lot as well and use the proceeds from the sale as further financial aid during our retirement years. However, we were recently informed by our agent, Michael Ballow, of Ballow and Hutchinson, that he was advised by the Taunton DPW that the vacant lot was not tied in to the city water system, and that there was a 5 year moratorium on digging up the road for new tie in's due to the recent sewer project on Duffy Drive. We do not know the exact date when this moratorium began or when it ends, however we do believe that the section of road that passes the vacant lot was resurfaced in the fall of 2011. This would leave at least three (3) more years on the moratorium. Our predicament is this. Federal Income Tax Law allows an exemption on Capital Gains Taxes on the sale of a vacant lot if it is sold either two (2) years before or two (2) years after the primary dwelling, in this case 37 Duffy Drive. With this moratorium in place, we currently have two (2) options. Option one (1) would be to sell our home at 37 Duffy Drive and pay a significant 15% Capital Gains Tax three (3) or more years down the road. Option two (2) would be to delay the sale of 37 Duffy Drive until the moratorium was up in three (3) or more years. However, option two would require me to delay my retirement for at least three (3) years due to the fact that we could not afford the financial burden required to maintain both properties in Taunton and Centerville without continuing to maintain my employment. Considering our age and the financial restraints that we will face in retirement, neither choice seems very appealing to us. We understand through Mr. Ballow and the Taunton DPW that the City Council has authority to grant a waiver to this moratorium in certain unique situations. My wife and I believe this is one of those unique situations and therefore respectively request that the City Council grant us a waiver on the 5 year moratorium and allow us the opportunity to tie our vacant lot into the Taunton water system in order to make it saleable. We ask that you and the City Council consider our request and respond back to us at your earliest convenience.

Dear Members of City Council,

I received a call from the City Clerk on August 1, 2013 regarding a request made by the City Council on July 30, 2013 to submit a response to City Council on the number of odor control devices on the landfill and the protocol for the use of these devices.

There are several devices used on the landfill with odor counteractant chemicals. The landfill uses a water truck that is filled with water and a dilution of deodorant that is sprayed on any surface of the landfill as needed. There is a mobile turbine deodorizer and 3 fogging units that emit a mist of the counteractant. These units are used when wind direction and weather conditions are favorable for odors in the community and many times used proactively prior to known odorous loads like Taunton sewer sludge deliveries. Waste Management also provides a bucket of deodorant crystals for haulers to throw into exceptionally odorous trucks after dumping. I requested Waste Management to submit to me a written response to these questions and verify the above information (see attached).

Taunton Sanitary Landfill Odor Control devices

Dear Mr. Duquette:

Pursuant to your request on August 1, 2013, Waste Management of Massachusetts, Inc. (WMMA) provides this letter to identify the number of portable odor control devices and describe the protocol for use of these devices during the solid waste handling operation at the Taunton Sanitary Landfill. The following provides a general description of each device and the manner in which the device is utilized during landfill operations.

- The landfill maintains one (1) high velocity turbine fan for application of odor counteractants and deodorizers. The turbine fan atomizes a mixture of water and odor counteractants/deodorizers and this device is utilized as necessary to mitigate the potential for odors associated with solid waste handling operations.
- 2) The landfill also maintains three (3) portable fogging units for the application of odor counteractants and deodorizers. These foggers are positioned at various locations on the landfill property and are utilized as necessary to mitigate the potential for odors related to solid waste handling operations.
- 3) The landfill utilizes a water truck for control of dust from the landfill travel roads and landfill surfaces. In addition, odor counteractants and deodorizers are utilized as necessary in the water truck for application on landfill roads, surfaces and the active working face to mitigate the potential for odors.
- 4) In addition, the landfill makes available dry deodorizing crystals for use by customers delivering solid waste to the landfill. The customers may apply the deodorizing crystals into the waste delivery container to assist in abating odors associated with odiferous solid waste deliveries.

The above odor control devices and procedures are utilized as needed during daily operations, when wind direction may be favorable for potential odors, and proactively during handling of known odiferous waste loads at the active working face.
