Dear Susan,

Municipalities from time to time face the exposure of tax takeover and/or vacant and unoccupied municipal owned proeprty. These properties are generally ineligible to be placed on the municipality's blanket property coverage. For the city of Taunton, our office placed one separate Property Policy with Lloyd's of London, effective 8/8/2013 – 2014 and added and deleted various locations as they came up during the year.

Unfortunately, four Property changes that were requested and bound during the policy year, were not invoiced to our office until September 18, 2014 and subsequently billed to the city on October 9, 2014, after the expiration of the policy and the city's fiscal year.

Two locations (5 & 7 Nickerson Street) were added 9/5/13, one location (84 Seekell Street) was deleted 3/16/14, one location (17 Barnum Street) was added 5/29/14 and lastly, 430 Barnum Street was added effective 7/1/14.

As we discussed, the invoices dated 10/9/2014 were the result of these policy changes. The net amount due of these changes is \$738.04.

We have taken measures to prevent this in the future. Rather than add and delete properties from this policy and await the endorsement for a premium amount, we will be issuing a new policy for each individual property in the future. Therefore, once the new policy is quoted and coverage bound, our office will invoice it promptly avoiding this situation in the future.


