Dear Mayor Hoye and Members of the Municipal Council:

As you know, this matter was referred to the Law Department to explore the potential for initiating litigation against this contractor. In this case, the City hired CBI Services, Inc. to build a water storage tank.

The written contract called for CBI Services to finish the project within a certain period of time. The contract also contained a liquidated damages clause in the event the contractor did not meet the timeline. A dispute arose as to whether or not the contractor was late, and if so, by how many days the contractor was late.

I am pleased to report that we were able to successfully negotiate a favorable settlement for the City. As a direct result thereof, the contractor agreed to pay liquidated damages to the City in the amount of \$75,000.00. The Water Enterprise fund will now have these additional funds available to it as a result of this action.

I wish to thank and commend Water Division Supervisor Cathal O'Brien, DPW Commissioner Fred Cornaglia and his team, and Lee Storrs and our water engineering consultants at CDM Smith for bringing this issue to my attention and for all the help they offered to the Law Department in successfully bringing this matter to a resolution. The City of Taunton was well-served by their diligence, hard work, and attention to detail.

First I would like to wish you and your family a happy, healthy new year. I would like to bring to your attention an issue that I hope we can solve. As you may know all of Taunton just received our new tax bill for the year and we all noticed that our taxes went up again. We all live in a very unsettling economy, but we all do our best to survive.

My issue, along with all the other residents, is that of Baker Rd (West) in Taunton. I have enclosed some pictures for you to look at. I don't mind paying my taxes however I shouldn't have to drive on roads that look like Baker RD West. I have lived on Dighton Ave for approximately 20 years and Bake RD West has never been fixed. This road is used frequently by the residents who live in this area. Baker Rd (West) is beyond fixing. It's also beyond anymore patch work. Continuing to put down patch work is just covering it with a band-aid. This road needs to be dug up and a new road needs to be placed down. The road also needs to be widened. It is too narrow. The road is also a damager for young and old who drive it. It does not have proper lighting and has no sidewalks, as it's a danger to walk on the pothole riddled street. I am seeking the assistance of your committee in obtaining a sewer easement from the City for property I own at 149 Berkley Street, Taunton, MA 02780.

By way of background, 149 Berkley Street abuts the southerly side of the Walker School property. The Walker School property was carved out of the property at 149 Berkley Street in approximately 1890. There is presently no sewer service on the portion of Berkley Street from Agawam Street south to approximately 300 feet before the intersection of Cooper Street. Additionally, I am unaware of any proposals to provide this portion of Berkley Street with sewer service in the intermediate future.

It is my understanding that there is an additional sewer stub for the Walker School property that was never utilized by the School, and the School in fact ties in to the municipal sewer system using a stub on the other side of the property.

I am requesting an easement 20 feet in width over the Walker School property for the purpose of tying into the Municipal Sewer System. Please advise as to any additional requirements the city may need in terms of any formal application or engineering documents.
