Dear Mayor Hoye, Council President McCaul, and Municipal Council:

I am writing in response to your request for information in regard to the City of Taunton's Reverse 911 system and additional emergency notification systems currently employed.

First, the City of Taunton is part of the **Code Red** alert system. This is a dial-out phone system that is hosted and controlled by the Plymouth County Sheriff's Department. Taunton was provided access to this system a few years ago as part of the Southeast Homeland Security Council's funding initiative. Since individual community financing of such systems is difficult, the Southeast Homeland Security Council provided funding to the Plymouth County Sheriff's Department to host, maintain, and operate the system, providing access to all communities in both Bristol and Plymouth Counties. The system, however, may only be used for defined emergency messaging (lost child, evacuation, etc.). This system does not provide text or e-mail messaging services. City residents may, and are encouraged, to register for the system by visiting http://www.pcsdma.org/codered.asp. Registration only is required if you do not have a listed home phone number.

Second, the Taunton Emergency Management Agency, for more than a year, has used Twitter to send out instant emergency text messages to individuals who sign up. The agency now has more than one-hundred individuals who have signed on, and the number of users continues to grow. At this time, this is the easiest way for individuals with text-messaging capability to register and receive the city's emergency notification messaging. There is no cost to an individual to participate, and an individual does not have to have a Twitter account to receive messages. One only needs to text "follow tauntonema" to 40404. We have done much testing with this system, and it has been well received by its users.

Third, both the City of Taunton and the Taunton Emergency Management Agency employ Facebook to communicate emergency messaging. As the mayor indicated during his State of the City address, the city has more than seventeen-hundred followers. TEMA currently has nearly six-hundred followers, and it regularly updates information during emergency and storm events. Residents are encouraged to "Like" either the city's Facebook or the Taunton Emergency Management Agency's Facebook pages to easily receive emergency information.

Fourth, the Massachusetts Emergency Management Agency recently launched Ping4, a new, free emergency alert. Residents may download the app from their app provider and will receive emergency messages from the Commonwealth and, in the very near future, from communities who wish to use the system. Once again, this system may only be used for emergency messaging.

Fifth, while continuing to utilize the latest technology to deliver emergency information, please note that we have not abandoned those methods that would appear to be antiquated. The Taunton Emergency Management Agency continues to employ a Public Information phone line, which typically is manned by TEMA volunteers during major emergency or storm events, cable television postings, and the city's web site, where emergency information is given a priority banner at the top of the city's web site. By clicking on the banner, city residents may review current emergency information-parking bans, etc. The city's web site also provides more detailed emergency information in the Emergency Management section of the site.

Finally, as you are well aware, the modes of communication greatly have changed. We continuously research and experiment with new ways of delivering important emergency information to the citizens of Taunton, and we would be happy to participate in any discussion regarding this issue.

RE: Modification of Definitive Subdivision – Myles Standish Ind. Park Phase IV expansion – Segment "B"

Dear Mayor Hoye and Members of the Municipal Council:

Please be advised the Taunton Planning Board has received a Modification of a Definitive Subdivision - "Myles Standish Industrial Park — Phase IV Expansion — Roadway Segment B - located off John Hancock Road (former Paul A. Dever School site) — to create 6 Industrial Lots.

#### The Modifications are:

Reduction of pavement width from 36 feet to 32 feet from Station 0+0 to Station 3+21.69. Concurrent with the pavement width reduction the plan modification seeks a waiver to eliminate the grass planting strip between the sidewalk and the curbing or edging from Station 0+0 to Station 2+21.70. Finally the plan modification seeks a waiver to allow a grass planting strip of 4 feet between the sidewalk and the curbing or edging from Station 2+21.70 to Station 10+36.83 to allow for light pole bases at the back of sidewalks within the roadway right of way.
