1. The angled parking (approx. 60°), and the relatively narrow curb cut on Bay Street suggest that this should operate as an entrance only. One-way and Do-Not-Enter signs would be appropriate here.





Ilhia Brava, Incorporated, doing business as T.J.'s Restuarant is an establishment licensed by the Taunton License Commission to serve alcoholic beverages to be consumed on the premises under the Liquor Control Act. The licensed premises are identified as 4 Alger Avenue. Mr. Pires is an officer of Ilhia Brava, Inc. and it appears that there is but one deed for both buildings, 413 Bay Street and 4 Alger Avenue. The Assessor recognizes only one lot, 413 Bay Street, but nonetheless, it contains two separate and distinct buildings. 



Dear Mayor Hoye and Members of the Municipal Council:

On March 14, 2013, the Law Department learned that the City acquired title to this parcel of real estate via the tax taking process. Upon my review of the docket, the Land Court entered judgment in the City's favor on December 3, 2010. The City has owned this property for over two years.

On March 15, 2013, I personally went to the property. There is a single family residence and two sheds on the property. It is safe to say that the property, and the structures thereon, are in deplorable condition. There is also a person residing there.

I had occasion to speak with the occupant. He states that he inherited the property years ago and that he was aware that back taxes were due. He also claims that he received no notice from the Land Court. He states that he has no means to pay the back taxes.

I wanted to bring this issue to your attention and request that you promptly act on this matter. I will investigate further to determine how much taxes were owed at the time of the judgment, for how long of a period of time taxes have been unpaid, and what kind of notice the owner received from the Court.
