The Taunton Area Vietnam Veterans Association will be holding their annual POW/MIA Remembrance Ceremony, Sunday March 29th, noontime, 1 Church Green, Taunton, Ma.

This year marks the 33rd year that the TAVVA and Taunton has remembered those that are still missing throughout all our wars. From World War I to the present there are over 91,000 that have not returned! From the Vietnam War alone there are 1637, of this, 39 are from our state of Massachusetts.

For many years our government has had an agency dedicated to searching for the POW/MIA's. Organizations like the TAVVA have dedicated themselves to making sure that funds are never cut for this important issue. So far by keeping this issue in the public's eye we have been successful. Unfortunately the last few years this agency has gone off course and the priorities are not in the correct order. After numerous complaints because of a slowdown of searches especially in the Southeast Asia area the Pentagon has responded. They have announced that as of January 9th reorganization has begun as a first step to building a new and improved agency to handle the POW/MIA issue. We hope that this will speed up the recovery of those that are still missing.

Guests speakers include, Mayor Tom Hoye, State Senator Marc Pacheco, State Representative Shaunna O'Connell, State Representative Keiko Orrall, Gold Star Mom Jane VanGyzen. National Anthem will be sung by Michaela Gordon.

Our special guest speaker is Dan Golden, retired Deputy Fire Chief of Braintree Fire Dept, President of the Massachusetts Vigil Society.

Dan has been an outspoken advocate of the POW/MIA issue!. He and the Mass Vigil Society go to Washington DC every Memorial Day and set up camp literally. A tent is erected near the Vietnam Wall and they inform people about the issue. Their dedication has crossed 31 years of time with no plans on stopping until all are accounted for.
