HOUSING DEVELOPMENT INCENTIVE ZONE PROGRAM

The Housing Development Incentive Program (HDIP) is intended to provide the City of Taunton's downtown and its surrounding areas with a development tool to increase residential growth, expand the diversity of the housing stock, support economic development, and promote neighborhood stabilization. The Taunton HDIP area (HD Zone) will enable developers to apply for local tax incentives as well as state tax credits to conduct redevelopment projects that lead to the creation of market rate housing.

Testimony will be taken on whether the City of Taunton shall approve both the designation of the Housing Development Zone and the proposed activities in the Housing Development Zone Plan.

Order for a first reading to be passed to a second reading

Ordered That,

\$250,000 is appropriated for the purpose of financing the repair, replacement and/or upgrade of subsurface disposal systems, or for loans to property owners for such purposes, including without limitation all costs thereof as defined in Section 1 of Chapter 29C of the General Laws; that to meet this appropriation the Treasurer with the approval of the Mayor, City Council, and Treasurer, is authorized to borrow \$250,000 and issue bonds or notes therefor under Chapter 111, Section 127B½ of the General Laws, Chapter 29C of the General Laws or pursuant to any other enabling authority; that such bonds or notes shall be general obligations of the City unless the Treasurer with the approval of the Mayor, determines that they should be issued as limited obligations and may be secured by the local system for revenues as defined in Section 1 of Chapter 29C; that the Treasurer with the approval of the Mayor, is authorized to borrow all or a portion of such amount from the Massachusetts Water Pollution Abatement Trust established pursuant to Chapter 29C and in connection therewith to enter into a loan agreement and/or security agreement with the Trust and otherwise to contract with the Trust and the Department of Environmental Protection

with respect to such loan and; that the Mayor is authorized to enter into a project regulatory agreement with the Department of Environmental Protection, to expend all funds available for the project and to take any other action necessary to carry out the project.

Request for Traffic Safety Improvements

Winthrop Street (US Route 44) at North Walker Street - Taunton, MA

Dear Ms. Perry,

The City of Taunton would like to request MassDOT implementation of traffic safety improvements at the intersection of Winthrop Street (US Route 44) and North Walker Street. The Winthrop Street approaches are under MassDOT jurisdiction. A project site location map is attached for your reference.

North Walker Street forms a tee shaped un-signalized intersection with Winthrop Street, where Winthrop Street is the "main" roadway. The North Walker Street approach is operated under stop control. All legs of the intersection have one travel lane in each direction. The intersection has no pedestrian nor bicycle accommodation. The land uses surrounding the intersection are commercial, with the exception of the northeast corner which has residential properties.

The intersection experiences a significant number of crashes, with a crash rate of 1.26 crashes per million entering vehicles, approximately twice the MassDOT District 5 average crash rate for un-signalized intersection (0.58) and the MassDOT statewide average crash rate (0.60) for the same type of intersection.

The City undertook a preliminary evaluation of the intersection in February 2014 in response to complaints and concerns received. Traffic volume data collected in February 2014 showed that approximately 14,500 vehicles navigate the intersection over the course of 12 hours (7:00AM-7:00PM). Traffic signal warrant analysis of this intersection conducted in March 2014 (copy attached for your reference) indicates that at least three signal warrants (Warrants 1, 2, and 3) are satisfied.

The basic finding is that the major street (US Route 44) volume is so large that the minor street (North Walker Street) vehicles cannot find adequate gaps. This finding is consistent with the large number of angle crashes and rear-ends associated with differences in driver aggressiveness.

A more recent traffic study for North Walker Street, dated December 2014, revealed that the roadway and this intersection are currently used as a commuting cut-thorough for many cars and heavy trucks destined towards Interstate 495. Approximately 8% of heavy vehicles use this intersection to cut through North Walker Street.

As currently envisioned, the intersection warrants the consideration of geometric improvements and the installation of a traffic signal system. Also to be considered are the upgrades of sidewalks including ADA compliance and improvement to substandard curb reveal.


