Pg. 1 Com. from Treasurer/Collector – Requesting amendment to Hopewell Park Order

### Order for a second reading to be ordained on a roll call vote

Ordered That,

\$270,250 is appropriated to pay costs of purchasing, for recreational purposes, by eminent domain or negotiated purchase or otherwise, a certain property together with buildings thereon, known as the Hopewell Park Complex consisting of 10 acres, more or less, as shown on the City Engineers Plan and located on Hopewell and Hamilton Streets in Taunton, Massachusetts, and also to pay costs of constructing a Water Spray Park located at the Hopewell Park Complex, including the payment of all costs incidental and related thereto; and to meet this appropriation \$70,250 will be transferred from available funds, and the Treasurer with the approval of the Mayor is authorized to borrow \$200,000 under and pursuant to Chapter 44, Sections 7(3) and 7(25) of the General Laws, or pursuant to any other enabling authority and to issue bonds or notes of the City therefor. The Mayor and any other appropriate officials of the City are authorized to take any and all other action necessary to carry out this project. The amount authorized to be borrowed by this order shall be reduced to the extent of any grants or gifts received by the City on account of this project.

FURTHER ORDERED: That the Mayor is authorized to file on behalf of the City of Taunton any and all applications deemed necessary for grants and/or reimbursements from the Commonwealth of Massachusetts deemed necessary under the Common Backyards Act (301 CMR 5.00) and/or any others in any way connected with the scope of this Order, and the City of Taunton and the Recreation Commission are authorized to enter into all arrangements and execute any and all instruments as be necessary on behalf of the City of Taunton to affect said purchase and accept any such grants.

FURTHER ORDERED: That the Treasurer is authorized to file an application with the appropriate officials of The Commonwealth of Massachusetts (the "Commonwealth") to qualify under Chapter 44A of the General Laws any and all bonds of the City to be issued pursuant to this Order, and to provide such information and execute such documents as such officials of the Commonwealth may require.

AN ORDINANCE AMENDING THE RESIDENT HIRING POLICY  
FOR PUBLIC WORKS PROJECTS

Chapter 2

ADMINISTRATION

Article XI. Hiring Policy for Public Works Projects  
Sections 2-305 through 2-311

*Be it ordained by the Municipal Council of the City of Taunton and by authority of the same as follows:*

**SECTION 1.** Chapter 2, Article XI of the Revised Ordinances of the City of Taunton, as amended, is hereby further amended by striking sections 2-305 to 2-311, inclusive and replacing sections 2-305 and 2-306 with the following:

**Sec. 2-305. Definitions.**

The term "bona fide resident" as used in this article, shall, unless the context otherwise requires, have the following meaning: any person for whom the principal place where that person normally eats and sleeps and maintains his or her normal personal and household effects is within the city limits of the City of Taunton. (Ord. of 9-25-84, sec 2)

**Sec. 2-306. Policy.**

(a) On any construction project funded in whole or in part by city funds, or funds which, in accordance with a federal grant or otherwise, the city expends or administers, or which the city is a signatory to the construction contract, the department involved shall determine whether the language in paragraph (b) of this section may be included in the contract without a detrimental effect upon the cost or quality of the project. If the department determines that the language may be included without detrimental effect, then it shall, to the extent practicable and to the extent allowable by law, include such language or its substantial equivalent in the contract.

(b) To the extent allowable by law, contractor shall work in good faith with the City to:  
(i) employ (or cause its contractors to employ) bona fide residents during construction and (ii) purchase goods and services from local vendors provided that the cost and quality is competitive with other sources.

**SECTION 2.** All ordinances or parts thereof inconsistent herewith are hereby repealed. This Ordinance shall become effective immediately upon passage.

Honorable Mayor Hoye and Members of the Municipal Council:

The impact caused by the hiring delay of 3 firefighters to replace positions vacated by retirement has caused 3 of our 4 platoons to run a firefighter short. To hire a firefighter at an overtime rate costs the City on average \$1000.00 for a 24 hour shift. This means that approximately \$6000.00 is being spent in overtime for these 3 vacancies over the course of our 8 day work cycles. The salaries that were vacated by the retirements were funded throughout the fiscal year. The total of these 3 vacated salaries is approximately \$3500.00 a week. This brings the cost of the delay to approximately \$2500.00 a week.

The SAFER Grant expires on December 28, 2014. As of March 29, 2014, the last date we have requested a disbursement from the federal government, we have spent \$659,360.74. We have a remaining balance of \$686,423.26. Discussions with members of the Fire Chiefs Association of Massachusetts have led me to believe that we will be able to write an amendment to the grant 90 days before expiration; allowing us to extend the performance period and spend the remainder of the federal funds. I know that both Fall River and New Bedford received such an extension and I am confident we will be able to do so as well.

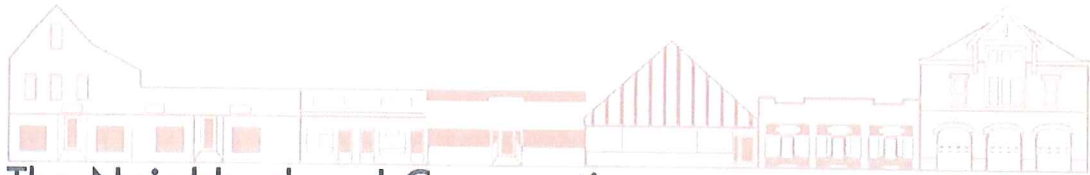

Thank you for taking the time to meet with me and Carolyn Medina from the Women's Development Corporation regarding the development of the Walker School Property at 135 Berkeley Street, in Taunton (the "Property"). As you know, Weir Land Village LLC, nominee of the Neighborhood Corporation ("the "Buyer") currently has a Purchase and Sale Agreement to purchase the Property (the "P&S"). By the terms of the P&S, the closing date for the sale is to be May 30, 2014, though this may be extended by notice from the Buyer.

This letter shall constitute formal notice of our extension of the closing date for sixty days as permitted under Section 9(3) of the P&S. As a result of this notice, the extended date for closing shall be July 30, 2014.

As you know, it is our intention to develop the Property into "workforce" housing. The Neighborhood Corporation has been fortunate to have several projects underway at the present time, so we have brought on Women's Development Corporation to be our partner in the Walker School project. Women's Development Corporation brings a wealth of experience in the development of housing, and their assistance on this project will help ensure that it can move more quickly going forward. Dear Property Owner/Agent,

An inspection was conducted on your property located in Taunton, Massachusetts on April 30, 2014 by Health Agent, Daniel Syriala, under Chapter 111 section 122, 127A and 127B of the Massachusetts General Laws: 105 CMR 400.00: State Sanitary Code. Chapter 1: General Administrative Procedures and 105 CMR 410.00; State Sanitary Code, Chapter 2: Minimum Standards of Fitness for Human Habitation.

The following defects in or on the premises constitutes a violation of the State Sanitary Code:

1. The property at 2 Church Avenue has been declared a public nuisance.  
Violation of City of Taunton Ordinance, trash is stored in containers without a closed lid. Noonan Trash toters have been brought to Church Street and piled up with trash. Trash is also on the property not in containers.  
Chapter 8, Section 8-28 Garbage, Trash, and Refuse  
**See Attached**  
e) Property Standards. All properties in the City of Taunton shall be maintained in accordance with the following property standards:  
(4) *Accumulation of Trash, Rubbish or Debris.* All property shall maintained in a clean and sanitary manner and free from the accumulation of litter, rubbish, trash or other debris, except in closed receptacles intended for such use.
2. Garbage and rubbish stored on the property, not in proper receptacles. Noonan Trash toters have been brought to Church Street and piled up with trash.  
410.600 Storage of Garbage and Rubbish  
(A) Garbage or mixed garbage and rubbish shall be stored in watertight receptacles with tight-fitting covers. Said receptacles and covers shall be made of metal or other durable, rodent-proof material. Rubbish shall be stored in receptacles of metal or other durable, rodent-proof material.  
Garbage and rubbish shall be put out for collection no earlier than the day of collection.  
**Order: Remove all garbage and rubbish from the property and store in watertight receptacles with tight-fitting covers. Toters must remain on your property. Provide tenants with enough receptacles to store all waste generated. Garbage may not be placed out for collection earlier than the day of collection. You must show a good faith effort to correct item #2 within 10 days from receipt of this letter.**

Both the occupant and owner are advised that under the State Sanitary Code 105 CMR 410.810 Access for repairs and alterations must be given to the owner up on reasonable notice, etc.

Both the occupant and owner are advised that under the State Sanitary Code 105 CMR 410.810, Access for repairs and alterations must be given to the owner thereof, or his agent or employees, upon reasonable notice, reasonable access, if possible by appointment, to the dwelling, dwelling unit, or rooming unit for the purpose of making such repairs or alterations as are necessary to effect compliance with the provisions of 105 CMR 410.000.

Pursuant to 105 CMR 410.830 of the State Sanitary Code, you are hereby ordered to begin necessary repairs of the identified defects. **You are required to make a good faith effort to substantially correct violation #1 & #2 within 10 days from the receipt of this letter.**

Failure to respond to this order may result in the assessment of a fine of not less than \$10.00 or more than \$500.00 for each day that such refusal continues. Further action will be taken to clear or repair the property at the owner's expense and/or condemn said property.

Should you be aggrieved by this order, you have the right to request a hearing before the Board of Health. A request must be received in writing in the office of the Board of Health with in seven (7) days of receipt of this order. At said hearing, you will be given an opportunity to be heard and to present witnesses and documentary evidence as to why this order should be modified or withdrawn. You may be represented by an attorney.

Any adverse party has a right to be present at the hearing. If these premise are occupied as rental housing, the occupants are entitled to the statutory remedies provided, a copy of this notice has been proved to them.



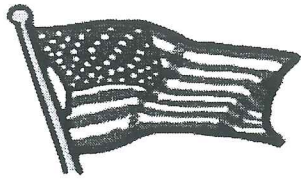


