Ordinance for third reading to be Ordained on a roll call vote

AN ORDINANCE

Chapter 4 - Buildings

ARTICLE III. Building Code

Be it ordained by the Municipal Council of the City of Taunton as follows:

Section 1. Article III of Chapter 4 of the Revised Ordinances of the City of Taunton, as amended, is hereby further amended by inserting after Section 4-43 the following new section:

4-44. Technology Fee Surcharge

There is hereby established a Technology Fee Surcharge of four percent (4%), which shall be in addition to the cost otherwise established by law on all permit fees, license fees, inspection fees, and enforcement levies charged by the Building Department and the Fire Department. The purpose of the Technology Fee Surcharge is to offset the cost to the city of the acquisition and maintenance of all

equipment and software and the training and administrative expenses associated with an electronic permitting system.

Section 2. All ordinances or parts thereof inconsistent herewith are hereby repealed. This Ordinance shall become effective immediately upon passage.

The sum of \$48,338.33 is appropriated in addition to the \$340,000 previously appropriated in the form of a "Special Purpose Appropriation", for the purpose of hiring outside consultants, outside legal counsel and other costs associated therewith, to determine the impact of the proposed tribal gaming development, and, in furtherance of this special purpose appropriation, the Mayor is hereby authorized to enter into such agreements with such outside, consultants and outside legal counsel upon such terms and conditions as the Mayor deems proper, expedient and in the best interests of the City.

Section 19-3.1: Procedure for the Assessment of Betterments For Laying of Common Sewers

SECTION 1. Section 19-3.1 of Chapter 19 of the Revised Ordinances of the City of Taunton, as amended, is hereby further amended by striking out subsection a. and inserting in place thereof the following subsection:--

- a. All betterments for the laying of common sewers shall be assessed against owners of property pursuant to the General Laws of the Commonwealth of Massachusetts.
- SECTION 2. Subsection b. of said Section 19-3.1 of said Chapter 19 is hereby further amended by striking out the words "betterment assessments shall be based upon a proportionate share of" and inserting in place thereof the following words:-- betterments shall be assessed at
- SECTION 3. Said subsection b. of said Section 19-3.1 of said Chapter 19 is hereby further amended by striking out the following words:-- "said Chapter 80 of"
- SECTION 4. All ordinances or parts thereof inconsistent herewith are hereby repealed. This Ordinance shall become effective immediately upon passage.

Sec 19-3.1. Procedure for the Assessment of Betterments For Laying of Common Sewers

Be it ordained by the Municipal Council of the City of Taunton as follows:

That Section 19-3.1 of the Revised Ordinances of the City of Taunton, as amended, is and hereby is further amended by adding the following:

Sec. 19-3.1 Procedure for the assessment of betterments for the laying of common sewers.

- a. All betterments shall be assessed against owners of property abutting a common sanitary sewer line pursuant to Chapter 80 of the General Laws of the Commonwealth of Massachusetts.
- b. All such betterment assessments shall be based upon a proportionate share of One Hundred (100%) percent of the costs permitted to be included in a betterment assessment pursuant to said Chapter 80 of the General Laws of the Commonwealth of Massachusetts, unless such formula shall violate the provisions of any state or federal law or regulation or the terms of any state or federal grant or the terms of any loan agreement reached between the City of Taunton and the Water Pollution Abatement Trust of the Commonwealth of Massachusetts pursuant to Chapter 29C of the General Laws of the Commonwealth of Massachusetts.

All ordinances or parts thereof inconsistent herewith are hereby repealed. This Ordinance shall become effective immediately upon passage.


Change the name of the roadway from: "Charles F. Colton Drive", to "Charles F. Colton Road".

Dear Members of the Municipal Council:

Please be advised that the recently constructed raised traffic island on Taunton Green and Broadway has been designed to increase pedestrian safety and ADA accessibility in the immediate area.

The traffic island contains three five foot walkways from Broadway to the Taunton Green. The areas within the island outside of the walkways have been constructed with stamped concrete.

The flashing yellow pedestrian warning signal has been moved from the easterly side of Broadway to the center of the raised traffic island. Although there are no current plans for a three-way walk signal at this location an electrical conduit has been trenched from the control box on Taunton Green to the center of the traffic island with a new handhold which may accommodate an actuated pedestrian walk signal in the future.
