


Dear Mayor Hoye and Members of the Municipal Council:

As you will recall, I have written to you each of the previous two times that the City has prevailed in this case. Following the *second* finding of Lack of Probable Cause, the Complainant again appealed, and the Commission decided to *sua sponte* amend the complaint to include an additional claim against the City that the Complainant herself did not allege.

The Law Department then decided it was in the City's legal interest to expend the time and resources to take the Complainant's deposition. Following this nearly day-long deposition, we transmitted the transcript of the deposition to the Commission.

The investigating commissioner has reviewed this additional evidence and has concluded that the last remaining claim against the City "is not sustainable on the merits." Accordingly, the City has prevailed on this case for a *third* time. Enclosed herewith you will find the MCAD's Order dismissing the Complainant's case.

ORDER

WHEREAS, Barbara Burgo (“Complainant”) filed a Complaint against City of Taunton (“Respondent”) on October 26, 2011, alleging discrimination in public accommodation on the basis of sex, race, and color in violation of M.G.L. c. 272, §98, the Commission hereby makes the following findings and issues the following Order.


- (1) The Complaint was duly investigated in accordance with the Commission’s practices and procedures.
- (2) On May 20, 2012, a Finding of Lack of Probable Cause was issued to the Complaint. Complainant appealed the determination. On September 26, 2012, the Complaint was remanded for further investigation.
- (3) On December 31, 2012, the Commission again issued a Finding of Lack of Probable Cause. On January 25, 2013, Complainant appealed the determination.
- (4) On May 10, 2013, the Commission *sua sponte* amended the Complaint to include a claim of retaliation in violation of G.L. c. 272, §98A, and issued a Finding of Split Decision. The decision affirmed the Finding of Lack of Probable Cause as to race and sex discrimination. The decision issued a Finding of Probable Cause as to the narrow question of whether Respondent retaliated against Complainant for having engaged in conduct protected by G.L. c. 272 when she was not permitted to speak at an October 25, 2011 City Council meeting.
- (5) After the matter failed to settle at conciliation, Respondent took Complainant’s deposition on January 16, 2014.
- (6) Complainant’s testimony admits that, while she submitted a letter to the City Clerk dated October 21, 2015, which she wished to be put on the agenda for

the meeting, she did not request in writing to speak at the City Council meeting on October 25, 2011.

- (7) Complainant's testimony further indicates that, in order for a member of the public to speak at a City Council meeting, procedural rules require that a City Council member make a motion that the person be allowed to speak, and that the motion must be seconded.
- (8) While Complainant alleges that she asked a City Council member to make such motion, and that the City Council member declined to do so, Complainant admitted in her deposition that she did not ask any other City Council member to make such motion. Further, no evidence was found that the City Council member's refusal to make such motion was motivated by retaliatory animus for Complainant's exercise of her rights under G.L. c. 272.
- (9) Pursuant to 804 CMR 1.15(5), the Investigating Commissioner may administratively close a claim if the public interest so requires.
- (10) As evidence developed after the Finding of Split Decision indicates that Complainant's claim for discrimination in public accommodation on the basis of retaliation is not sustainable on the merits, the public interest requires that the claim be closed.
- (11) For the reasons set forth above, I hereby determine that the Complaint should be closed pursuant to 804 CMR 1.15(5).

**THEREFORE**, the Commission hereby orders that the case be DISMISSED.

Members of the Committee on Solid Waste,

The odor complaints received by this office are nuisance odor complaints ranging from operational odors, sludge truck odors, and the occasional landfill gas odor. The question regarding if these odors are a public health concern was brought up earlier this year. I contacted some colleagues and the Massachusetts Department of Environmental Protection (MA DEP) regarding this question and it resulted in following:

- Air quality testing requires expensive equipment and in order to conduct a test you must select a specific contaminant, VOC, or the like to test for. There is not a single test to determine the presence of every contaminant dangerous to public health.
- The Taunton Landfill does not produce any gases that would be a threat to public health and is not required to conduct air quality tests.

Based on the guidance from the MA DEP the Board of Health has not required Waste Management to conduct air quality testing nor has the Board hired a 3<sup>rd</sup> party to conduct these tests on behalf of the City.

One test that is done periodically is a surface scan. This is a test performed by a 3<sup>rd</sup> party engineering company to identify areas of the landfill that may be emitting methane. This is a tool used by the operators of the gas collection system (Fortistar Methane Group) to improve the gas collection system and generate power. MA DEP does not require surface scans be done as part of their permit because this landfill does not produce enough gas to warrant it.

Waste Haulers:

Every year the Board of Health permits all trash haulers that drive through the City of Taunton. These trucks are issued a permit sticker that is required to be placed on the driver's side door of the truck so they are easily identified.

In early August, Taunton residents, who are also members of the Latin Community and Latin Pass, requested the City hire a Spanish-speaking Police Officer. As you may recall, there were many members of our Community at the Taunton City Council Meeting in early August when a vote was taken to call for the Spanish-speaking Police Officer list. We were proud to feel as if our Council and Mayor were willing to hear us and act on our request. We all left that meeting feeling as if our voices were heard and that you would begin interviewing for a Spanish-speaking Police Officer in a timely manner. The two (2) non-Spanish speaking positions that were approved that night are already being hired. We know the Taunton Police Department has been understaffed for some time now. Because of this understaffing, we reasonably expected to have the third (3<sup>rd</sup>) position, designated as a Spanish-speaking Police Officer, be hired during the same Civil Service list term, which expires on November 1<sup>st</sup>, 2015.


Since that motion, we have followed the City's progress in hiring a Spanish-speaking Police Officer. It is our understanding that Jorge Vernal is at the top of the list for the Spanish-speaking Police Officers. Many of us know him, as he has grown up in our City. He and his wife are raising their family here in Taunton.

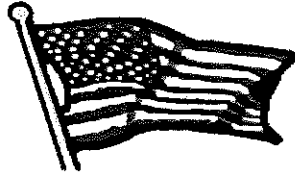
Last week, we were extremely disappointed to find that the City has not taken the actions necessary to hire a Spanish-speaking Police Officer. Because of this delay, the City may lose its best opportunity to hire a highly qualified Spanish-speaking Police Officer, who actually grew up here in Taunton.

Every other Public Safety hire in this City has a Taunton residency requirement and we believe that it is extremely important and deserves to be supported. We are asking the City to take action in preserving the current Spanish-speaking Police Officer list, which will include Mr. Vernal and provide the City the best opportunity to hire a highly qualified Spanish-speaking Police Officer who is also one of our own. We understand the city has taken steps to preserve a civil service list in the past 3 or 4 years.

We trust that you will take all steps necessary to preserve this list, so that Mr. Vernal and the City of Taunton do not miss this important opportunity.
