Meeting was called to order at 7:02 p.m. by Chairman Lamb.

1. Minutes of the meetings from November 19, 2014. Motion made by Commissioner Mullen to accept the minutes. Motion was seconded by Commissioner Thomas. Motion passed unanimously.
2. **Section 15 Sunday Hours** – Apex Ventures d/b/a Andy's Supermarket. Commissioner Mullen made a motion to approve the extended hours, opening at 10:00 a.m. instead of noon. Motion passed unanimously.
3. **Approval of the 2015 Common Victualler Licenses** – Commissioner Thomas made a motion to approve and issue the licenses according to the list provided. Commissioner Mullen seconded the motion. 4. **Approval of the 2015 Liquor Renewals** – Commissioner Mullen made a motion to approve and issue the licenses according to the list provided. Commissioner Thomas seconded the motion. Motion passed unanimously. Attached and incorporated herein is a list of the acceptances for the Entertainment, Alcohol and Amusement Device Licenses.
5. **New Business** – Appearing before the Board was David Briggs, Francis Silvia and George Andrews of the Italian Naturalization Club. They stated that they were late in submitting the renewal application and inquired as to what the next step would be.

The Board advised them that they would not be able to sell any alcohol after midnight on December 31, 2014. The gentlemen stated that they would just close the facility altogether until the new application was approved by the ABCC so as to avoid any issues. The Board scheduled a special meeting for December 30, 2014 to decide on the Club's application.

Detective Lt. McCabe requested approval from the Board to publish a notification in the Taunton Daily Gazette that the police department would be performing compliance checks with the local establishments in the 2015 calendar year. Commissioner Mullen made a motion to approve the notice. Commission Thomas seconded the motion. Motion passed unanimously.
