

CITY OF TAUNTON LICENSE COMMISSION MEETING MINUTES OF THE MEETING December 4, 2013 7:00 p.m.

Chairman Peter Lamb Commissioner Brendan Mullen Commissioner Bruce Thomas

Meeting was called to order at 7:00 p.m. by Chairman Lamb.

1. Confirmation that corrective measures are in place in accordance with the disciplinary decisions from the November 13, 2013 meeting:

Carlos Desa d/b/a Desa Package Store – Appearing before the Board is Carlos Desa, Owner. Mr. Desa stated that he has participated in the STOP program and shows his certification. Chairman Lamb stated that he has satisfied the Board's condition for corrective measures. Commissioner Mullen made a motion to accept the STOP certification as compliance of the corrective measures. Commissioner Thomas seconds the motion. Motion passed unanimously. Chairman Lamb stated that there is one other issue before the Board – that Mr. Desa has not yet put forth his application for renewal. Mr. Desa explained that he was waiting for his son to take the food safe test and that he should have it in a few days. Commissioner Thomas stated that there is a problem because the application was due in November. Mr. Desa stated that he forgot and that he should have it all together in a few days. Chairman Lamb stated that the deadline was November 30th and we are now beyond the deadline and unable to submit it to the ABCC. Mr. Desa asked what he should do. Chairman Lamb stated that he will need to reapply. Commissioner Thomas stated that the license will expire on December 31st. Detective Lt. McCabe explained to Mr. Desa the procedure for reapplying. Mr. Desa stated that he would start the procedure tomorrow. Commissioner Mullen explained that it was out of the Board's control. Chairman Lamb informed Mr. Desa that December 31st would be his last day for alcohol sales.

Frank's Good Times — Appearing before the Board was Attorney White and Mr. Texiera and stated that all the employees had attended the STOP program. Chairman Lamb stated that this was what the Board was looking for in terms of corrective measures. Commissioner Mullen made a motion to accept the corrective measures for Frank's Good Times. Commissioner Thomas seconded the motion. Motion passed unanimously.

2. Communication from the Executive Office of Health and Human Services – Department of Transitional Assistance:

Eva Mara Swami Corporation d/b/a Tremont Liquors — Appearing before the Board was Jignesh K. Pachani, Manager/Owner. Chairman Lamb commented that Mr. Pachani had sent his bookkeeper to the last meeting. Mr. Pachani stated that yes; and when he was made aware of the problem with the machine, he called and had it blocked. Chairman Lamb stated that the Board was confused as to who the Manager was. Mr. Pachani explained that she was the bookkeeper. Her husband works there as well. Mr. Pachani stated that he has another store and works approximately 20 hours in Taunton. Commissioner Thomas asked if he was aware that he was required to be at the store 50% of the time. Mr. Pachani stated no, but would take steps to rectify the situation; perhaps promote an employee to manager status. Chairman Lamb stated that proper paperwork needed to be filed to change a manager. Commissioner Mullen stated that the Board's next meeting was January 15, 2014 and at that time, the Board would like to know what his plans are. Chairman Lamb suggested a letter in the file. Commissioner Mullen made a motion to put a letter in the file regarding this issue. Commissioner Thomas seconded the motion. Motion passed unanimously.

3. Yamato Japanese Steakhouse – Application to Transfer License. Appearing before the Board was Attorney Chris Coleman and Mr. Hong Zhi Yang, proposed manager. Attorney Coleman stated that the hours and name of the establishment will stay the same, as well as the menu. He further explained that Mr. Yang was a US citizen who had quite a bit of restaurant experience and it was his intention to spend 40+ hours a week at there. Chairman Lamb asked if this was a straight purchase of license assets and operation. Attorney Coleman stated yes. Chairman Lamb stated that their renewal was in and the Board could do the transfer, but before it is approved, the old management must stay on. Commissioner Thomas asked if there were any intended changes to the inside of the restaurant. Attorney Coleman stated no. Commissioner Mullen made a motion to approve the license transfer application. Commissioner Thomas seconded the motion. Motion passed unanimously.

- 4. Fore Kicks III Limited Partnership – New License. Appearing before the Board was Tom Teager, Owner & President and Pat Teager, Owner and Vice President. Teager stated that they were looking for a license for a separate facility upstairs. This facility would be a separate entity with hours of operation when the main facility is open. Mr. Teager went on to state that the hours of operation for the Kickback Club would be 12:00 p.m. - midnight. Chairman Lamb asked if it would be open 7 days a week. Mr. Teager stated 7 days for one facility; possibly both. Chairman Lamb stated that the Board may have an issue with that. Commissioner Thomas stated that the license is usually 11-11. Chairman Lamb stated that if Mr. Teager wanted, his license could be restricted. That the Board could extend it either way, but that he could not open and close it as he saw fit. Mr. Teager stated that he may want to restrict the hours to 12-11, but maybe 12-12 would be better. Commissioner Mullen asks if there is another entrance. Mr. Teager states that there is an entrance through the front door, but there are cameras in the Fore Kicks area. Commissioner Mullen asked if anyone could come in off the street and order drinks. Mr. Teager stated yes, but they only want a beer and wine license for the benefit of their customers and that it is not their intention to advertise. Commissioner Thomas asked Mr. Teager to explain the layout of the facility - which he did. Chairman Lamb asked if there would be anything in the general area of the facility. Mr. Teager stated no. Commissioner Mullen asked if they had a distributor. Mr. Teager stated that that they needed to locate one. Commissioner Mullen made a motion to approve the application with the operating hours of 12- 12 Sunday through Saturday. Commissioner Thomas seconded the motion. Motion passed unanimously.
- 5. Baha Brothers Sandbar and Grill - Communication requesting Change of Hours. Appearing before the Board is Peter Hebert and Bill Strojny to request a change in hours to accommodate a breakfast menu. Chairman Lamb asked if this was a permanent request or a temporary request. Mr. Hebert stated it would be a permanent. Chairman Lamb commented that 7:00 a.m. was an early hour. Detective Smith commented that alcohol cannot be served before 10:00 a.m. Detective Lt. McCabe stated that usually the hours of operation coincide with the hours on the license. Commissioner Mullen asked if there were a lot of people who wanted alcohol at 7:00 a.m. Detective Smith stated that this wouldn't be much different than OVs Restaurant in East Taunton. Chairman Lamb stated that the Baha Brothers were supposed to come before the Board and clarify the backroom. Mr. Hebert stated that he had been in contact with Robert Pirozzi and the engineer for Jay Dorsey needed to sign off on one more item and then it will be all set. Commissioner Mullen asked how the permits would be. Mr. Hebert stated that the Tiki Room would be a function hall only. He added that the doors had locks. Chairman Lamb asked if the Fire Department was okay with locks on the doors. Mr. Hebert stated yes. Chairman Lamb asked if breakfast would be served in the main facility. Mr. Hebert

stated yes. Chairman Lamb asked that the issue with the backroom be completed by January 15, 2014. Mr. Hebert suggested that it possibly could, but he didn't want to commit. Chairman Lamb stated that it needs to be done. Commissioner Thomas asked for clarification regarding the issues needed to get the permit. Mr. Hebert gives an explanation regarding painting a cap. Commissioner Thomas asked if all this time, it was not complete. Mr. Hebert stated that it was okay but then it wasn't. Commissioner Thomas stated that by the next meeting it should be all done. Chairman Lamb stated that all the information should be sent to Detective Lt. McCabe a week before the meeting so that the Board knows the status. Mr. Hebert agreed. Commissioners Mullen and Thomas state that they are okay with the change of hours to accommodate breakfast. Chairman Lamb inquired again about the hours. Commissioner Thomas made a motion to change the hours of operation for the Baha Brothers Sandbar Grill to open at 7:00 on Saturday and Sunday for the service of food only and Sunday at 10:00 a.m. for the liquor license under the brunch rules. Commission Mullen seconded the motion. Detective Smith stated that if breakfast didn't work out, that they would need to come back and change the hours. Mr. Hebert agreed. Motion passed unanimously.

6. **2014 License Renewals** – Attached and incorporated herein is a list of the acceptances, non-renewals and late renewals.

Commissioner Thomas motioned to adjourn. Commissioner Mullen seconded the motion. Motion passed unanimously. Meeting adjourned at 9:40 p.m.
