SCOPE OF WORK

The City of Torrington Parks and Recreation Department is looking to attain the services of a company to repair an asphalt side walk at Coe Memorial Park, to include repair/removal of existing asphalt as necessary and overlay existing asphalt walkway and drainage swale.

SPECIFICATIONS

1. Prepare existing asphalt sidewalk surface for an overlay, by removing any/all uneven or cracked surface areas.
2. Apply 1.5" finish course asphalt overlay on an existing side walk. Surface area is approximately 10'x77' or approximately 770 square feet.
3. Apply 1.5" finish course asphalt overlay on an existing asphalt drainage swale. Surface area is approximately 19"x60' or approximately 97 square feet.
4. Apply a new 1.5" finish course asphalt drainage swale. Surface area is approximately 19"x30' or approximately 50 square feet.

5. Note: If existing asphalt is removed in any area, contractor must apply 2" finish course asphalt.
6. Contractor is responsible for disposal of all materials.
