SCOPE OF WORK

The City of Torrington Parks and Recreation Department is looking to attain the services of a company to repair fire escapes at the Armory located at 153 South Main Street, Torrington.

SPECIFICATIONS

- 1. Fire Escape North Side of the Building (off Coe Place):
 - a. Check all welding on the Fire Escape and repair as necessary to meet current building and fire codes.
 - b. Check all anchors and hardware and secure fire escape as necessary.
 - c. Paint as necessary.
- 2. Fire Escape South Side of the Building (opposite Coe Place):
 - a. Remove plywood decking.

- b. Repair/weld Fire Escape floor and steps to meet current building and fire codes, including no spacing greater than 4" in diameter.
- c. Install welded mesh along the sides of the Fire Escape opposite the building to meet current building and fire codes, including no spacing greater than 4" in diameter.
- d. Check all welding on the Fire Escape and repair as necessary to meet current building and fire codes.
- e. Check all anchors and hardware and secure fire escape as necessary.
- f. Paint as necessary.
- 3. Contractor is responsible for clean up and disposal of all materials.
