The City of Torrington Parks and Recreation Department is looking to attain the services of a company to supply and install an 85 Gallon Natural Gas Hot Water Heater at the William L. Besse Municipal Pool.

SPECIFICATIONS

- Supply/Install 85 Gallon 365,000 BTUH Natural Gas Hot Water Heater.
- Pipe water lines to heater.
- Pipe gas to heater from gas valve to inlet on heater.
- Install vent piping to heater.
- Supply/Install mixing valve.
- Supply/Install temperature gauge.
- Fill and start water heater.
- Remove and dispose of old State 80 Gallon, 500,000 BTU Hot Water Heater.
 - Existing connections 1 ¼ Lines; Natural Vent Chimney
 - Existing conditions Male: 2 Toilets, 2 Urinals, 2 Lavatory Sinks, 4 Showers; Female: 3
