General description of project: The conversion of an existing tank into two fractionation (frac) tank systems and a pump room, construction of a truck loading containment area, process drains, cast-in-place concrete structures, electrical, mechanical, HVAC, and instrumentation systems complete and operational. The Regional Fats, Oils and Grease (FOG) Facility Construction Project will include five separate bids/contracts:

Contract No. 1 - Civil Site Work Contract No. 2 - Structural Work Contract No. 3 - Process Work Contract No. 4 - Electrical Work

Contract No. 5 - Instrumentation Work

Contractors can bid on one contract, multiple contracts or all five contracts.
