Questions and Answers 11/22/10

1) Q) How many rooms/locations does this system pertain to?

technicalities, and to award the contract as will best serve the public interest.

- A) This pertains to one (1) room
- 2) Q) What type of Camera (covert, dome, vandal-proof, etc.) would you like and how many?
 - A) The minimum is three (3) cameras and the type will be covert.
- 3) Q) What type of Microphone is preferred (ceiling mounted, table-top, Carotid) and how many?
 - A) The required minimum for microphones is one (1) and the location will be flexible as long as it is covert.
- 4) Q) Who will pull the wires? Who is responsible for wiring the rooms (TPD or vendor)?
 - A) The vendor will be responsible for all installation of the system that will be supplied.
- 5) Q) Is a push-button start and stop at the door required?
 - A) No, this is not required.
- 6) Q) The bid specs are very specific to one particular vendor. Is the TPD open to other ideas and

vendors?

- A) The TPD will accept other ideas and vendors pertaining to the system to be offered.

 - A) The Network System in place at the TPD is Microsoft.
