**ALTERNATE BID - BID FORM**

The contractor may elect not to bid on this alternate work. If so he will not be disqualified from being selected for the initial "Processed green waste" contract work. If the Contractor elects not to bid on the alternate bid work then he shall leave this Alternate Bid Form blank.

This alternate bid price is for work associated with "bucket truck with crew" to trim snags and remove damaged hanging tree branches and remove severely storm damaged trees that are located within the street right of ways and City properties. This part of the alternate bid work shall also include the satisfactory cleanup of the green waste debris resulting from the tree trimming and cutting operations. City inspectors will designate which damaged trees shall be removed completely and which trees shall be trimmed only. The "bucket truck with crew" work shall include chipping, cleanup and disposal of materials trimmed or cut. This alternate bid work shall be measured by the number of hours of actual use of the "bucket truck with crew" in performing hanging branch and tree removals. In addition to the hourly payment for "bucket truck and crew", the disposal of the chipped materials resulting from the bucket truck work will be paid for under the "Processed green waste" contract bid item. Payment for "bucket truck with crew" will be the unit price bid per hour multiplied by the actual measured quantity of hours per "bucket truck with crew". Multiple bucket trucks with crews may be used and will be tracked separately and total hours compiled for calculating payment. The City inspector shall monitor actual hours of bucket truck work for measurement for payment. The bucket truck shall have a minimum 50 extension. A minimum 3 person crew will be required. The "bucket truck with crew" schedule does not have to precede the green waste pickup and can be done independently of that work's priority schedule.
