**QUESTIONS SUBMITTED AND ANSWERS 12/15/11:**

**Q1) Will the vendor have to submit a Performance Bond, Material Bond, Labor & Material Bond?**  
**A1) The City of Torrington reserves the right to retain the Bid Bond or Certified Check on bids below \$25,000.00 as a Performance Bond. Material & Labor Bonds are not required with this bid.**

**Q2) The Workrite trousers appear on both the stand alone bid and on the uniform bid. Is this correct?**  
**A2) The bid for the Workrite Trousers is a separate bid. The trousers are not included in the uniform bid.**

**Q3) How shall the responses for each bid be submitted?**  
**A3) The bids shall be submitted separately. Each submitted proposal shall include the 5% bid bond.**

**Q4) Will the city award by item or the total bid?**  
**A4) The City of Torrington reserves the right to award or reject any or all bids, or any portion thereof, to waive technicalities, to award the contract to a bidder other than the lowest bid and to award the bid and/or contracts to one or more bidders submitting essentially identical proposals and, that in the city's judgment, will best serve the public interest.**

**Q5) Is the color of the sweater black or dark navy?**  
**A5) The color that is required for the sweater is dark navy.**

**Q6) On the dress tie, Item P, are they a wool/polyester blend or just polyester?**  
**A6) The dress tie should be wool/polyester blend.**

**Q7) On item U, 5.11 Tactical Uniform Polo, is logo 2 to be used?**  
**A7) The embroidered logo (pg. 2) to be used.**

**Q8) On item S & T, 5.11 Tactical Uniform Polo, Office White and Office Blue is logo 2 to be used?**  
**A8) Logo 3, embroidered type badge to be used on items S & T, 5.11 Tactical Uniform Polo, Office White and Office Blue. Badge Rank will be determined when placing order.**

**Q9)** Will the city accept submitted “equivalent to” on the Blue Dress Shirts, items # F & G, Flying Cross 65R5425 & 15W5425?

**A9)** The product requested is Flying Cross Blue Dress Shirts. If bidder is taking an exception, it must be noted and must include sample with submitted bid.

**Q10)** On the Officer’s white hat Item # R, can the description be provided?

**A10)** The Officer’s white hat is a Cushion Air Comfort Fit, White Naugahyde, Fire Bell Crown Cap, Style W303560 or equivalent. It has a white top, gold band, gold buttons and no chin strap.

**Q11)** Will the city accept submitted “equivalent to” on the Elbeco #310 & #3310, White Dress Shirts, items # D & E?

**A9)** The product requested is Elbeco White Dress Shirts. If bidder is taking an exception, it must be noted and must include sample with submitted bid.

### **QUANTITIES**

The quantities listed are estimated annual quantities only and not necessarily the quantity the City will order. The City reserves the right to increase or decrease the quantities stated in accordance with the unit prices bid.

### **BID SUBMISSION**

The bidder is required to quote firm, fixed pricing. Cost to include any set-up charge. All prices shall be on the **F.O.B. destination basis; no additional costs shall be allowed for (inside) delivery; no additional surcharges allowed for fuel.** The City is exempt from all taxes and fair trade restrictions.

## TORRINGTON FIRE DEPARTMENT UNIFORMS SPECIFICATION DETAILS

**A. Fire Chief Shirt:** Navy, Short Sleeve, 4.5 oz Nomex 111A700NMX 45 with patches sewn on both left and right sleeve, 3/4" below and centered on shoulder seam of both shoulders & with epaulettes.

**B. Fire Chief Shirt:** Navy, Long Sleeve 4.5 oz. Nomex 111A705NMX 45 with patches (See above for further descriptions)

**C. Winter Sweater:** Blauer Style 210 - Commando Sweater 70% acrylic/ 30% wool with shoulder and elbow patches, name tab, badge tab, reinforced rib knit collar in V - neck design, epaulettes and Dept. patches sewn on upper sleeve.

**D. Long Sleeve Shirt:** White Elbeco 310

**E. Short Sleeve Shirt:** White Elbeco 3310

Shirts: F & G shirts are to be Flying Cross in Light Blue with 2 patches on each shirt. Patches sewn 3/4" below and centered on shoulder seam of both shoulders

**F. Short sleeve:** Flying Cross # 65R5425

**G. Long Sleeve:** Flying Cross # 15W5425

**H. Socks:** Thorlo #WSXL -13 Size 9 - 12.5

**I. Socks:** Thorlo # WSX -13, size 9 - 12.5

**J. Garrison Belts:** 1½" black with gold or silver buckle. 13 gold/8 silver

**K. Patches:** City of Torrington patches - sample to be supplied. Patches will be ordered in quantities of 100 and will be stored by the vendor to be sewn on as needed

**L. Dress Blouse:** Dark Navy – Must be Custom Made (NOT STOCK) Provide color sample – Double Breasted – Officers; Single Breasted – Privates; Hash marks as required; Sleeve Braid as required (Red – Privates; Gold – Officers). Sleeve Patches to be provided. **Material** – Serge 8330-8107 13 1/2 oz. Rarford Fabric (55 poly/45 wool). Measurements must be taken at Fire Headquarters.

**M. Dress Trouser:** To match exactly to Dress Blouse (L) above, Must be Custom Made (NOT STOCK) provide color sample. Stripes (Red – Private; Gold – Officers). **Material** – Serge 8330-8107 13 1/2 oz. Rarford Fabric (55 poly/45 wool). Measurements must be taken at Fire Headquarters.

**N. Fire Fighter Hat:** Sentry # F303 style #9 - Dark Navy

**O. Hat Band:** ½" silver or gold metal with buttons, color to be specified at time of order. All with elastic center for adjustment

**P. Black Ties:** Snap on and hand tie - black

**Q. Trench Coats:** London Fog DB2034 or Whaling 761MT Darien – Black. 3 or 4 season coat, water repellent with zip out lining, black, full length, double breasted, raglan sleeve/shoulder.

**R. Officer's White Hat** – Cushion Air Fire Bell or equivalent – Comfort Fit White Naugahyde Crown Cap, W303560. No Chip Strap, Gold buttons.

**S. Office White** - Short Sleeve – Style 41060 – OFFICE WHITE: Embroidered: Collar Insignia –Chest – Badge & Name (Gold) – TFD on Sleeves – All Block Letters (gold) - Size M-XXL

**T. Office Blue** - Short Sleeve – Style 41060 – OFFICE BLUE: Embroidered: Collar Insignia –Chest – Badge and Name – Size M-XXL

**U. Plain Blue** - Short Sleeve – Style 41060 – PLAIN BLUE: Chest Logo – TFD on Sleeves – All Block Letters (red) – Size M-XXL

**V. Game Work Shirt** - #810 – Denim Collar – Logo left Chest

**W. Game Work Shirt** - #811 – Soft Collar – Logo left Chest

**NOTE:** Items C, G, L, M, N, O, P & Q are typically replaced throughout the year as needed. A uniform inspection is normally conducted by the Fire Department during the month of January. Dress uniform and accessory replacement requirements are determined and ordered as a result of the annual inspection.
