- Q1. Does the City of Torrington want to continue the current theme with the amount of annuals that are currently in the park? Is there a set budget for the annuals and bulbs?
- **A1**. The proposals shall include a percentage of annuals vs. perennials proposed in accordance with design plans. The Not to Exceed Budget of \$90,000 shall include all labor and materials necessary to meet all terms and conditions outlined in the RFP.
- Q2. Should the proposal include an estimate for moving and leaf clean up?
- **A2.**The proposals should include complete maintenance within the garden beds, including leaf clean-up and weed removal. Maintenance outside of the garden beds including the lawn areas will be maintained by others.
- Q3. Should the proposal include an estimate for snow removal on the walkways?
- A3. Snow removal of the walkways will be maintained by others.
- **Q4**. Is the City of Torrington currently satisfied with the way the gardens are maintained and planted now or would they like to go in a different direction?
- **A4**. The City of Torrington has been satisfied with the current maintenance of the gardens resulting in contract extensions with the current contractor to meet the full term of the original contract (5 years total.)
- **Q5**. Would you be able to give me an idea of how many hours per week the current gardener uses for maintenance from March-October? A rough average would be okay.
- **A5.** The current contractor completed approximately 1280 staff hours to complete the tasks outlined in the contract.
- **Q6.** Is the city looking for regular maintenance of the park or planting annually?
- **A6**. All aspects of maintaining Coe Memorial Park Gardens
