- Any materials removed during this project, shall be removed off site at the expense of the contractor. All grass and debris shall be removed from any cracks before being sealed.
 All debris shall be removed from the surface prior to performing any of the work specified.

 - Seal Coating Tarconite Pavement Sealer (Professional Grade) by NEYRA
 Industries, Inc. To be installed in accordance with manufacturers specifications.
 - Crack Sealant CRAFCO Sealant by CRAFCO, Inc. To be installed in accordance with manufacturers specifications.
 - Line Striping approved traffic marking paint. Survey mark-out and apply two inch (2") white playing lines in accordance with basketball court standards. To be installed in accordance with manufacturers specifications.
