# HYDRAULIC REVERSIBLE TRIP EDGE SNOW PLOW WITH STEEL MOLDBOARD

The City of Torrington is seeking quotes on <u>one (1) "J" Style American (Frink) Hydraulic</u> reversible trip edge snow plows with steel moldboard (American Snow Plow model 4511-S1SA or Equivalent)

**GENERAL**: These specifications describe a Power Reversible Trip Edge "J" style snowplow.

#### **MOLDBOARD ASSEMBLY:**

Shall be 45" high and 11' long. The moldboard sheet shall be formed from not less than 10 gauge steel. The upper portion of the moldboard shall project over the cutting edge so as to form a continuous solid integral shield.

#### **SPRAY GUARD:**

Guard shall bolt to the top moldboard flange or reinforcement. It shall consist of 12"wide x1/4" thick rubber belt, metal retaining strap and necessary mounting hardware.

#### **CUTTING EDGE:**

The cutting edge one (1) in number should be from ½" x 8" C-1085 steel, punched to 12" centers and supported by a reinforcement from not less than 4" x 4" x 34" steel angle. The cutting edge shall be reversible for double wear.

#### **CURB SHOES:**

The moldboard shall have two fabricated steel curb shoes (one at each end of the moldboard).

## TRIPPING EDGE MECHANISM:

The edge shall be of the single edge design, which shall activate whenever the cutting edge comes into contact with an obstruction on the pavement. Spring adjustment shall be provided so as to alter the precharge of the springs for varying plowing conditions.

Reverse method: hydraulic ram reverse.

Quote price delivered to Street Department, 107 Arthur Street, Torrington, CT 06790. Insidedelivery will be required. Prices quoted shall be net – delivered to destination. Bids quoting other than F.O.B. Destination may be rejected.

All costs submitted in Proposal must include inside-delivery, warranty and shipping charges.

Pricing must be held firm for the duration of contract.

Please note that the City will not be held responsible for transmission problems or other errors that could occur.
