The door hardware for the replacement bi-fold doors at opening #A110 shall be :Stanley Commercial Door Hardware BF125N.

Where the "48" Coat Hook Strip" is called out on 2/A1.01, provide 6 equally spaced coat hooks, as identified in the specification, over a 48" length.

The mirrors are 36" tall unless otherwise indicated.

Where the finish schedule identifies a color as "TBD", the color shall be selected to match the architects sample from the manufacturer's standard range of finishes.

1/PFPE-1 PLUMBIING & FIRE PROTECTION NEW WORK PLAN, sprinkler note indicates "TYPICAL FOR 5" Provide one new sprinkler head centered in each bathroom, in addition to the three indicated in plan, for a total of 5 heads. See 3/A1.01.

Eliminate the Sanitary Napkin Dispenser form the Legend; This does not occur on this project.

090600 FINISH AND COLOR SCHEDULE: revise both TOILET ROOMS to indicate CTW full height all walls with in bathroom. Revise FINISH NOTE 1 also, wall tile shall be full height.

2.2D Delete 1-7 and Replace with:

- 1. Basis-of-Design Product: Bobrick; B-828.
- 2. Description: Designed for dispensing all commercially marketed all-purpose soap in liquid form.
- 3. Mounting: Deck mounted on vanity.
- 4. Capacity: 34 oz.
- Materials:
 - a. Spout and Shank Assembly: Above the counter, chrome plated ABS plastic spout with integral shank to accommodate up to 2" thick counter. Unit equipped with a spring loaded 180 degree rotatable lid with concealed locking mechanism for top filling.
 - b. Removable Foam Mixer Cartridge.
 - c. Air Pump: Diaphragm operated electronic air pump.
 - d. Soap Bottle: Translucent, shatter resistant polyethylene.
 - e.Pump and Soap Delivery System: Plastic gear pump submerged in the bottom of the bottle pumps soap through a vinyl tube to spout.
 - f. Bottom Housing: Water resistant, ABS plastic housing attached to the bottom of the bottle houses PC board, motor, and the gear pump housing.
 - g. Battery Pack: Water resistant, plastic hold 4 Alkaline "D" cell batteries.

- 2. Mounting: Surface mounted, with concealed opening in bottom for filling.
- 3. Minimum Capacity: 250 seat covers.
- 4. Exposed Material and Finish: Stainless steel, No. 4 finish (satin), 22 gauge.

"Plan PFPE-1, Fire Protection New Work Plan, Sprinkler note #1 says "Typical for 5", but only 3 sprinkler heads are shown on the plan. Please clarify." **See KBA Clarifications.**

"The specifications call for ceramic wall/floor tile, resinous flooring, resilient tile, sheet carpeting, and rubber tile. Please specify locations." See the Finish Schedule provided in the Specifications, 09 06 00.

"The drawings indicate a sanitary napkin dispenser (SND). Please specify quantity and type." **See KBA Clarifications.**

"Per our conversation, there are no limits referenced in Article 11 of the General Conditions, nor is there supplementary conditions that amend this section. The City is making the contractor responsible for securing an Owner's Protective Liability policy, however, we will need the limits." **See the Insurance section of the Instructions to Bidders, Page 4.**

"Plan A1.01, Large Scale Toilet Plan Area-A, there are symbols in boxed cap. letters: B, C, E, that are not associated with any wall sections or types, please clarify what these letter designations represent." These are reference to patching notes. See added patching legend. Note changes in previous addenda.

"Plan A1.01, note above Toilet Plan Legend, says "See Drawing R0.02 for mounting heights and dimensions..." there is no drawing R0.02 in the bid set. Please clarify." "Revise the reference to" R0.02" to read "A1.01".
