REQUIREMENTS

- Lift meets or exceeds Americans with Disabilities Act Guidelines.
- Lift must comply with all OSHA and State of Connecticut safety guidelines.
- Lift to be supplied with but not limited to battery, battery charger, battery console cover, ballast weights, waterproof controls, foot rest, seatbelt assembly, waterproof seat pad, storage cover, and arm rest assembly.
- Arm rest assembly to have retractable arm rests.
- Minimum 300 pound lifting capacity.
- Vendor must be licensed and insured and will be required to submit

- this information if awarded the bid.
- Must submit at least three (3) references with contact information regarding delivery & installation of similar project.
- Vendor responsible for delivery, all required assembly, setup, and training of City of Torrington employees on the operation of the lift.
- Vendor to provide binder containing but not limited to manufacturer's information, Lift Operation Manual, maintenance requirements, warranty documentation, etc.
- Vendor and manufacture to provide unlimited no charge technical assistance on lift operation.
- Vendor responsible for confirming with manufacturer that provided lift complies with the City of Torrington pool design and geometry.

WARRANTY

- Non electronic lifting system components full minimum three (3) year warranty.
- All electronic and motor components (other than battery) must have a full minimum two (2) year warranty.
- Battery: one (1) year pro rated (90) days @ 100%, (90) to (365) days @ 50%.
- Warranty the products or services against defective material or workmanship and to repair or replace any damage or marring of products occasioned in transit.
- Furnish adequate protection from damage for all work and to repair damages of any kind, for which he or his workmen are responsible, to the premises or equipment, to his own work or to the work of other contractors.
- Indemnify and hold harmless the City, its agencies, agents, offices, servants or employees from any action, lawsuit or judgment arising out of defects in its products, materials or workmanship, negligence in its activities or breach of its agreement with the City, including the cost of defense and counsel fees.
- Articles which in any respect fail to conform with the specifications upon which the award is made will be rejected and held subject to the Bidder's disposition and expense.
- Warranty date of ownership is the date that City of Torrington signs-off on installation of the lift.

VENDOR SPECIFICATIONS

All vendors must include specifications with bid Proposal. Failure to submit specifications with bid proposal may result in disqualification of bid. Items in catalogs must be clearly marked and pages tabbed.

The City of Torrington reserves the right to award or reject any or all bids, or any portion thereof, to waive technicalities, to award the contract to a bidder other than the lowest bid and to award the bid and/or contracts to one or more bidders submitting essentially identical proposals and, that in the city's judgment, will best serve the public interest.
