The minimum rates to be paid labor of the various classifications shall be in accordance with current schedule of wages established by the State Labor Commissioner as provided in the General Statutes of Connecticut, as revised.

A bid bond with an acceptable surety, or a certified treasurer's check in the amount of 10% of the total bid shall be submitted with each bid. The successful bidder must furnish a 100% Performance Bond and a 100% Labor and Material Payment Bond.

The bidder agrees that 12% (appropriate % as agreed upon by the State) of the awarded contract value shall be performed by disadvantaged business enterprises (DBE) as approved subcontractor or owneroperator of construction equipment. The successful bidder must indicate the disadvantaged business enterprise(s) it intends to utilize to achieve the above stated percentage prior to the award of the contract.

The City of Torrington reserves the right to reject any or all bids, to waive technicalities, to award the contract to a bidder other than the lowest bid, and to award the contract as it feels will best serve the public interest. It is anticipated, but not guaranteed, that a contract will be awarded within approximately 60 days after the bid opening and that the successful bidder will be required to start work within fourteen (14) days after receipt of a written Notice to Proceed.
