## 4. New Business:

a. Site Plan #981

Applicant: Dennis E. Andrews, Jr. Location: 847 Migeon Ave.

Proposal: Construct new glass repair shop, repair/sales

Dennis E. Andrews was present to discuss his proposed auto glass and glass repair shop at 847 Migeon Avenue. The property was formerly used as a miniature golf course and is located next door to Scarpelli's Restaurant. The proposed 3,360 sq ft building will have 4 garage bays and include a 12 ft x 20 ft office area. 2 of the bays will be used for storage while the other 2 bays will be used for auto glass repair. The Committee reviewed plans titled, "Property Survey – Lot Line Revision, Property of Joseph J. Scarpelli, Et Al, Migeon Avenue, Torrington, Connecticut," sheet 1 of 2, dated June, 2010, by GM2 Associates, Inc., "Site Plan Property of Joseph J. Scarpelli, 847 Migeon Avenue, Torrington, Connecticut," dated 7/8/10, sheet 2 of 2, by Robert D. Trottier, P.E., and Architectural Plans, titled, "Executive Glass, Migeon Avenue, (Route 4), Torrington, CT., Sheets A1-A2, by Borghesi Building & Engineering Inc. The building proposed will be a metal building with tinted split-face bloc with a block accent band, Artic White or Cool Sierra Tan colored Liberty "Valley Rib" metal wall panels and metal trim colored Tahoe Blue. The building will be placed sideways on the lot with the east elevation facing Route 4, Migeon Ave. The office entrance, garage bays and parking lot will be located on the north elevation and side of the lot. The Committee questioned the applicant regarding lighting and signage. The applicant has not yet decided on signage but believes he will have a free standing sign in front of the building and a sign over the office entrance. He agreed to incorporate the building's address in the free standing sign. He understands signage over 50 sq ft in size will require separate site plan and ARC Approvals. The only lighting proposed will be required lighting next to exterior doors. That lighting proposed will be full cut-off wall pack lighting.

Motion by Mrs. Boe,  $2^{nd}$  by Mr. Mileti, to make a favorable recommendation on the project to the Planning & Zoning Commission as presented. Motion carried unanimously.
