a. Applicant: Allan Borghesi, Borghesi Building & Engineering, Inc., for Kevin Lee

Location: 1875 East Main Street

Proposal: Construct retail building, ice cream shop, 1,350 sq. ft.

Allan Borghesi, Borghesi Building & Engineering, Inc., was present for Kevin Lee who proposes to construct a retail building, 1,350 sq. ft. in size to sell ice cream. The building will be a free standing building in the southwest corner of the parking lot at the existing Fuji Shopping Center owned by Mr. Lee. The building's location is shown on a Site Plan titled, "Kevin Lee, 1891 East Main Street (US RTE 202), Torrington, CT," by Borghesi Building & Engineering Co., Inc., dated 6-28-12, sheets SP1 & SP2. The Architectural Plans submitted are titled, "Kevin Lee Retail Store, East Main Street, Torrington, CT," by Borghesi Building & Engineering Co., Inc., dated 6-26-12, sheet A2. Mr. Borghesi explained the building will have "Hardie" clapboard siding, Navajo Beige & Artic White colors with dark red awnings and roof trim. The parapet will conceal the heating and cooling equipment. Mr. Borghesi agreed to prominently display the street address on the building. Existing plant material will be relocated. Proposal: Construct two storage buildings at existing bulk propane facility

The buildings will be metal buildings, green in color with white garage doors.
