GENERAL REPORT 8/25/10

Current activities: Planning and implementation of one year anniversary celebration of the singer/songwriter network of torrington, ct. Event activities include; Monday, September 20th "featured performer" Joey Sexton @ T-Place Sports Bar & Grill 6 to 9pm; Tuesday, September 21st- Champagne toast @ Nirvana Health & Juice Bar; Wednesday September 22nd @ The Torrington Historical Society 5 to 8pm (outdoor performance) w "featured artist" Gale Gardner; and "The Grand Finale" Sunday September 26th 4 to 7pm @ The Nancy Marine Studio; Featuring "Buzz Turner, Eric Parradine, Bill Benson, Coyote, and Mark Papallo. We are also negotiating with The Nutmeg Conservatory Orchestra to accompany these performing artists. There will be a one year anniversary sub-committee meeting Wednesday, August 25th 3:00 in room 314 at city hall.

The singer/songwriter network currently has 100 enrolled members. The network has drafted the use of facebook to help administrate daily operations and communications. The facebook service has garnered the recognition of over 500 "fans" to help promote and market the network to entities and interests that otherwise may not have been reached by other marketing avenues. We feel that facebook has been a positive step forward in obtaining and disseminating information that is relevant to the local music community in regards to it's growth and development. The network would like to engage with the commission (A.C.T.) for more discussions on how they can work together more closely and come up with ideas and strategies that will help both down town venues and venues throughout greater torrington.

It has been a tough year for the entertainment business, but what this year has shown us is that we must seize the opportunities as they arise or our industry will not survive. The singer/songwriter network is here to support what appears to be a burgeoning artistic community to facilitate a process that has been abandoned in the current hysteria of musical hype ad naseum. There are artists who play and perform for the love and passion of their musical ideas. Those are the artists we want to support. The services we ultimately want to provide, will help the artists by leveredging their time and maximizing their resources.
