#### 1. <u>Call to Order:</u>

Chairman Richard Calkins opened the public hearing at 7:01 p.m., Torrington City Hall Council Chambers, Room 218, 140 Main Street, Torrington, CT

#### 2. Attendance/Announcement by Chairman:

Chairman Calkins announced present and serving on the Commission this evening will be Greg Mele, Paul Summers, Donna Greco, Jim Bobinski, Jon Sheaffer and Richard Calkins. Also present is City Planner Martin Connor.

Mr. Connor noted the Connecticut Main Street Program had a grant program going with as much as \$10,000 available for a downtown project. Mr. Connor wrote up a summary of Artists Relocation and attracting artists to our downtown and Mr. Connor's summary made it through the preliminary rounds, and now he can spend more time, along with the assistance of artists such as Danielle Mailler and Ed Jaffe working on this grant. This is worth a try, and the Commission Members agreed it was a way to perhaps obtain some grant money and bring some attention to our Artists Relocation Program.

Also Mr. Connor noted the Fifth Thursday meeting will be at the Goshen Northwest COG office tomorrow night, and there will be talk about the CLEAR map. Mr. Rick Lynn will be speaking of the Regional Transportation Plan which will be updated, and this Commission will be involved as well. Mr. Connor will attend, and any other Commissioners who are interested are welcome to attend.

- 2. Per the recommendation of Assistant City Engineer Matt Walsh, P.E., the landscape plantings shall planted outside of the City right-of-way on Cook Street.
- 3. A Sign Permit shall be required for the proposed Valero Gas signage on the canopy, building and free standing sign.
- 4. It is recommended that the applicant follow the advice of the Fire Chief, Gary Brunoli contained in a memo to the City Planner dated 10/5/15.
