### 1. <u>Call to Order:</u>

At 7:00 p.m., Chairman Richard Calkins called the meeting to order in the Torrington City Hall Council Chambers, Room 218, 140 Main Street, Torrington, CT

## 2. Attendance/Announcement by Chairman:

Chairman Calkins announced present and serving on the Commission this evening will be Greg Mele, Jon Sheaffer, Paul Summers, Jim Bobinski, Melanie McMillan, Greg Perosino and Richard Calkins. Also in attendance is City Planner Martin Connor.

Mr. Connor announced the Conservation Commission has been working on putting together a worthwhile and meaningful Earth Day Celebration. There are many people involved and it will take place on Saturday, April 23, 2016 at Coe Park from 9:00 to noon, assigning spots around town for Earth Day clean up and from noon to 1:30 p.m. there will be an Earth Day picnic in the Park, and Mayor Carbone will kick off the City of Torrington Litter Prevention Campaign, which the Conservation Commission is going to sponsor. There will be many more people and more activities.

a. Enforcement Update – no new information at this time.

b. Special Exception 16-307

Applicant: The McCall Foundation, Inc.

Location: 417 Prospect Street

Proposal: Group Care Facility, 7 - 12 beds

(public hearing is closed)

Commissioner Greg Perosino was not present at the public hearing. Mr. Perosino has met with City Staff, reviewed the file, and listened to the audio recording of the public hearing held on March 16, 2016.

All regular Commissioners present tonight were at the public hearing and will vote on the matter this evening. The Alternate Commissioners will not participate or vote on this matter.

Mr. Calkins read Corporation Counsel Jaime LaMere's memo to the Commission dated April 4, 2016.

Mr. Connor read his memo to the Commission dated March 21, 2016.

Mr. Mele noted it will be a benefit to the neighborhood to have the barn demolished. Mr. Calkins prefers to have historical structures remain.

In response to a question from Mr. Summers, Mr. Connor stated at the public hearing the applicant has agreed to install a fence on the property.

Proposal: Group Care Facility, 7-12 beds with the following conditions and recommendation:

- 1. The proposed light pole for the parking area and outside lighting fixtures shall be reviewed and approved by the Zoning Enforcement Officer prior to installation.
- 2. A Landscape Architect or Landscape Gardner shall prepare a landscape plan to be reviewed and approved by the Zoning Enforcement Officer prior to installation of the landscaping.
- 3. A 6' solid board fence shall provide screening for north side of the parking area along the property line. Additional solid board fencing shall be installed in the northwest corner area of the lot where the existing dilapidated barn is to be removed.
- 4. The applicant shall address the comments from Ray Drew, Administrator, WPCA, contained in his memo to the City Planner dated 2/16/16.
- 5. It is recommended that the applicant follow the advice of Fire Chief Gary Brunoli contained in his letter to the City Planner dated 2/16/16.

c. Zoning Regulations Amendment

Applicant: City of Torrington Planning and Zoning Commission Proposal: Zoning Regulations, Amendments to Section 7.2,

Flood Hazard Regulations (continued from March 16, 2016)

At 7:55 p.m. Chairman Calkins opened the public hearing and stated serving on the Commission this evening will be Commissioners Paul Summers, Jim Bobinski, Melanie McMillan Jon Sheaffer, Greg Perosino, Greg Mele and Richard Calkins. Also present is City Planner Martin Connor.

Commissioner Mele read the legal notice which was published in the Republican American newspaper.

Mr. Connor overviewed the proposal, Rista Malanca, the City's Inland Wetlands Enforcement Officer and Flood Plain Manager, has gone through an intensive four day training class on flood plain regulations, and during the class she had an opportunity to meet the State DEEP Rep who oversees the regulations, which were revised and proposed revisions to meet with the DEEP regulations. Changes have occurred over the years, and it is important that we follow the recommendations and our regulations are with FEMA and DEEP. It provides more clarifications, and it makes it more efficient for the City to use the regulations.

Mr. Calkins noted FEMA has updated all of Connecticut's maps, except for Litchfield County.

Mr. Connor recommended approval, as it provides better protections for the citizens of Torrington. The Regional Planning Agency agrees with the proposal, and recommends all towns in this area also update their regs.

There were no comments from the public.

At 8:00 p.m. Chairman Calkins declared the hearing closed.

MOTION by Mr. Mele to APPROVE: Zoning Regulation Amendment Applicant: City of Torrington Planning and Zoning Commission Proposal: Zoning Regulations, Amendments to Section 7.2, Flood

The Commission finds the proposal to be consistent with the City's Plan of Conservation and Development. The effective date of the regulation amendment shall be the day after publication of the legal notice of decision in the Republican American. MOTION seconded by Mr. Perosino, unanimously carried.
