MINUTES OF MEETING HELD October 4, 1994

1.1 Meeting was called to order by Chairman Rebholz at 7:11 P.M.

1.2 Roll call taken showed Chairman Robert L. Rebholz, Vice Chairman Frederick J. Darling and Clerk Andrea R. Wood present.

1.3 There were no additions/deletions to the agenda.

Town Treasurer Amy Collins met with the Board to discuss her hours and compensation. She informed the Board that she was hired to work 20 to 24 hours but that she works 30 hours to get her job done. Chairman Rebholz informed her that at this time there could not be any increase in her salary and she stated the she knew that. She submitted for the Board to review a listing of department heads and their salaries for the Board to review.

At this time she asked the Board if she could speak briefly on two matters. The Board granted her the time. 1) She inquired about the status of the tax bills as the school payment will be due 11/15/94 for the amount of 1,183,373.05. The consensus of the Board was that we would need to borrow and requested Ms. Collins to check on rates with the banks and return on October 18 to borrow for the school payment. 2) She inquired status of tax title for Kadar Corp/Hicks property. Selectperson Wood said she would check with Counsel.

Continuation of John M. Wolons Class III hearing from September 6, 2.3 1994. Mr. Wolons stated that around October 20 or 21st the suit will be dismissed or appeal not renewed. As of October 3rd, has site plan approval from Planning Board as agreed in July, 1994. Selectperson Wood stated that the Board could grant the license but hold the license until such time as all permits are set. Chairman Rebholz moved to grant a Class III License to John M. Wolons d/b/a Affinity Corp. for property at 58 Old Turnpike Road contingent upon all approvals of permits, Site Plan Special Permit and rest of criteria are met. Motion was withdrawn by Chairman Rebholz. Selectperson Wood moved to grant Class III License to John M. Wolons d/b/a Affinity Corp. contingent on Planning Board and Building Inspector being satisfied but released only when everything needed to be open for business is satisfied with Site Plan Special Permit and is attached to Seconded by Rebholz. Three in favor with none opposed. Chairman Rebholz closed the hearing at 7:52 P.M.

Elaine Olden met with the Board as Townsend's Representative to M.R.P.C. As a result of her letter complaining that the meetings were a waist of time, they updated their goals and objectives which solves the problem. Selectperson Wood suggested that the format used might help the Board of Selectmen track projects. Copy of M.R.P.C.'s was

submitted.

Ms. Olden had attended a Tax Exempt workshop back in April. She submitted at this time a summary to the Board for their review.

3.2 Chairman Rebholz moved to approve driveway permit #12-94 for Gunther Zisler, M39/B/5/L0, Christian Circle. Seconded by Wood. Three in favor with none opposed. A detailed map was submitted by the Land Use Administrator Elaine Olden depicting exactly where the driveway was.

At this time, Ms. Olden informed the Board that applicants need to completely fill out atleast one or both parts of the driveway application as the Board approves driveway cuts under two sets of regulations.

3.1 Ms. Olden told the Board that information was missing from this driveway permit application. An X needed to be placed next to the box for Town Way. The Board approved the Chairman marking the X and requested that a memo be sent to the Highway Superintendent to see that the applicant correctly fills out the driveway permit application or it will be sent back in the future for completion. Chairman Rebholz moved to approved Driveway Permit #11-94 for Steven Amichetti, M30/B5/L3, 115 Turner Road. Seconded by Wood. Three in favor with none opposed.

3.3 Chairman Rebholz moved to approved One Day License #15-94 for the South Fitchburg Hunting and Fishing Club in conjunction with a Lunker Fishing Derby to be held Saturday, October 8, 1994 from 9AM to 6 PM but NO ALCOHOLIC BEVERAGES SERVED PRIOR TO 12 Noon. Seconded by

Darling. Three in favor with none opposed.

Selectwoman Wood requested a line be added to the permit application to be filled out indicating hours of the function. The Board agreed to review the One-Day Liquor License policy for possible updating.

3.4 Chairman Rebholz moved to approved One Day License #16-94 for the South Fitchburg Hunting and Fishing Club in conjunction with a Member's Fishing Derby to be held Sunday, October 16, 1994 from 9AM to 6 PM but NO ALCOHOLIC BEVERAGES SERVED PRIOR TO 12 Noon. Seconded by Darling. Three in favor with none opposed. Midnight expiration time to be changed to 6:00 P.M.

3.5 Chairman Rebholz moved to approved One Day License #17-94 for the South Fitchburg Hunting and Fishing Club in conjunction with a Turkey Raffle to be held Sunday, November 20, 1994 from 12 NOON to 6 PM. Seconded by Darling. Three in favor with none opposed. Midnight

expiration time to be changed to 6:00 P.M.

3.6 Chairman Rebholz moved to sign lease/purchase agreement for the new Fire truck. Seconded by Darling. Three in favor with none opposed. The Board requested that the Town's Insurance Agent be contacted for

certificate of insurance as stated in the agreement.

3.7 Chairman Rebholz moved to sign Mass. Highway Memorandum of Agreement for Chapter 85 funds in the amount of \$655,033 to be paid in two payments. Seconded by Darling. Three in favor with none opposed. The Board requested that the Highway Superintendent submit to the Board of Selectmen a list of work to be done with the funds.

3.8 Chairman Rebholz moved to approve Townsend Ford as low bidder at \$21,245.00 for the purchase of pick up truck as approved at the September 29, 1994 Special Town Meeting for the Highway Department. Seconded by Wood. Selectperson Wood questioned what will happen to old truck? Save for parts as discussed or sell it? Board requested a memo be sent to Superintendent Felton inquiring as well as consideration of extended warranty and what the warranty length currently is.

At this time the Board noted that when the new fire truck and pickup truck for the Highway Dept. arrive, insurance listing is to be viewed to see that it is updated with new equipment and old is deleted. Follow up to Executive Secretary Tim Bragan at a later date.

Selectperson Wood moved that the Board reconsider bid award for pick up truck. Seconded by Darling. Three in favor with none opposed. Need warranty information and prices of extended warranty.

- 4.1 Selectman Darling moved to approve payroll warrant 14P. Seconded by Wood. Two in favor with one abstention (Rebholz).
- 4.2 Selectman Darling moved to approve bills payable warrant 14B. Seconded by Rebholz. Three in favor with none opposed
- 4.3 Chairman Rebholz moved to approve minutes from September 6, 1994 and September 13, 1994. Seconded by Wood. Three in favor with none opposed.
- 4.4 The Board reviewed and approved bi-weekly purchase orders.
- 4.5 Chairman Rebholz announced and released press release regarding Halloween from Chief May.
- The Board reviewed letter received from the Building Inspector regarding the bleachers at the playing field behind Spaulding Memorial School. Chairman Rebholz suggested getting in touch with the Board of Health first to see if they can take the debris at the landfill and work with the Highway Department to remove the bleachers. Notification to be given to the Recreation Commission.
- Chairman Rebholz moved to designate Rural Housing Inc. as Townsend's Representative to the M.H.F.A. Housing Program. Seconded by Wood. Three in favor with none opposed.
- 4.7 The Board tabled discussing/action on request from Fire Chief for change in office hours schedule. Selectperson Wood not satisfied that scheduled breaks or weekend hours during burning permit time covered. Needs to be adjusted. Tabled until October 18th meeting.
- 4.9 EXECUTIVE SECRETARY REPORT
 - a) Board notified that the A.B.C.C. approved alteration to the Townsend House Restaurant.
 - b) Board reviewed letter sent to Antonioni's Office from CONCEWM.
 - c) Board agreed to schedule meeting to view Centrex proposal for new telephone equipment.

- d) Board reminded of Mass. Selectmen's Assoc. Meeting to be held Saturday, October 15, 1994. Three members to attend checks to follow.
- e) Board was informed by Mrs. Sleeper that the Squannacook School published the wrong new hours for the Town Hall/Annex buildings. Advised it should be corrected.
- f) Selectperson Wood questioned the Board if the hearing scheduled for October 11th regarding local establishment still needed to be held or just set criteria to be met in the future. The Board should request report from Nashoba Board of Health for each inspection set by the local Board of Health with Nashoba to take place over the next six months. Selectperson Wood moved to rescind vote to hold hearing scheduled for October 11th with notice to the individual. Call to be made to owner and followed up with a letter that the meeting is cancelled for October 11, 1994. Seconded by Darling. Three in favor with none opposed.

Chairman Rebholz motioned to adjourn if there was no other business. Times Free Press reporter Kate Walsh stated she had two questions for the Board.

1) She questioned if she had missed the announcement of the Selectmen's meeting schedule. Selectperson Wood responded that they are still every other week until business warrants weekly meetings. 2) Questioned auction of golf course. Board responded they are not aware of the auction at this time.

Chairman Rebholz moved to adjourn the meeting at 9:23 P.M. Seconded by Darling. Three in favor with none opposed.
