2.1 Joint meeting with Capital Planning Committee, RE: Bylaw.

The Board met in conjunction with the Capital Planning Committee and the Finance Committee for review of the bylaw (attached) and discussion of funding capital expenditures in the future. Discussion included the following topics: financing of capital expenditures, percentage of budget used to purchase capital, the bylaw and its purpose, the procedure for approval of the CIP, cost of financing, leasing capital items, condition of infrastructure, and maintenance of capital inventory. After much discussion, all members of the Capital Planning Committee and the Finance Committee supported the bylaw contingent upon one change to the existing wording, 2<sup>nd</sup> page section E change from "approval" to "recommendation". Andrew Sheehan, Town Administrator will be reviewing the capital purchases made in the last five years to see what the town has spent on Capital needs. The Finance Committee in conjunction with the Board will be discussing an amount based on the percentage of the annual budget to be put into the capital stabilization account each year and in addition looking to put any non-reoccurring revenues in the stabilization fund.
