To Whom it May Concern:

Please be advised that this office represents the interests of Superior Sheet Metal of Holbrook, Inc. ("SSM"), with respect to labor, services, and materials which SSM provided for the use and benefit of the above-referenced property pursuant to a contract with Goguen Construction, Inc. ("Goguen"). Please also be advised that SSM has completed its contract work and is presently owed a contract balance of \$84,748.01.

Accordingly, please accept this correspondence pursuant to M.G.L. c. 254, §4 as notice of SSM's lien on the above-referenced property. For more information, please refer to the Notice of Contract enclosed herewith and recorded at book 54307, page 363 of the Middlesex (South) Registry of Deeds. Dissolution of this lien may be obtained by forwarding the full balance owed as outlined in said Notice of Contract to the undersigned, in exchange for which my client would be willing to execute the appropriate paperwork.

Please also accept this correspondence as a demand pursuant to M.G.L. c. 93A, §11. Goguen is withholding \$84,748.01 from SSM, while claiming backcharges of some \$40,000. Twenty thousand dollars of the claimed credits are for the elimination of induction units from the original design, which elimination was accounted for in SSM's bid. Goguen only notified SSM of other claimed backcharges (which SSM absolutely disputes) well after the work was complete. Although Goguen only claims backcharges with respect to a portion of the funds owed SSM, Goguen has withheld all of said funds. It has become apparent that Goguen has no good faith basis in fact or law to withhold any funds from SSM, much less the balance between the back charges and the total due. By withholding the amount due SSM, Goguen is causing SSM to incur damages and is compromising

SSM's ability to pay subcontractors. In the event that SSM is not paid in full within seven (7), this office has been instructed to file suit for the triple damages and legal fees allowable under M.G.L. c. 93A, §11.
