SELECTMEN'S MEETING MINUTES JANUARY 25, 2011 - 7:00 P.M. Selectmen's Meeting Chambers

I. PRELIMINARIES:

- 1.1 The meeting was called to order at 7:02P.M.
- 1.2 Roll call vote taken showed 3 members present: Chairman Robert Plamondon, (RP) Vice-Chair Sue Lisio, (SL) and Clerk Nicholas Thalheimer, (NT).
- 1.3 There were no Chairman's additions or deletions.
- 1.4 NT moved to approve the meeting minutes for December 13, 2010. SL seconded. Unanimous vote. NT moved to approve the meeting minutes for January 4, 2011. SL seconded. Unanimous vote. NT moved to accept but not release the Executive Session minutes for December 21, 2010. SL seconded. Unanimous vote. NT moved to accept and not release the executive session minutes for January 4, 2011. SL seconded. Unanimous vote.

II. APPOINTMENTS / HEARINGS

2.1 7:05P.M. Public Hearing, RE: Joint Pole Petition for Turnpike Road.

RP moved to open the public hearing. A sign-in sheet was circulated. NT read the legal notice into the record – see attached. RP reviewed abutters list and return receipts. RP queried the audience for support and objections. Jim Dee, Unitil Representative explained the reasons for the pole relocation is due to the new development on Turnpike Road. NT disclosed he did reside on Turnpike Road. Andrew Sheehan informed the Board; the petition will not be released until payment has been received from Verizon, noting Unitil did pay their portion of the invoiced amount. NT moved to approve the application for the pole and wire relocation. SL seconded. Unanimous vote. NT moved to close the public hearing at 7:15P.M. SL seconded. Unanimous vote.

III. MEETING BUSINESS:

- 3.1.Accept \$4,000.00 grant from the Community Foundation of North Central Massachusetts to the Townsend Public Library to fund Sunday hours during the winter months.

 Andrew Sheehan, Town Administrator explained the donation was made through the Community Foundation and is to be used to extend hours for the operations of the Library on Sundays see attached. NT moved to accept \$4,000.00 grant from the Community Foundation of North Central Massachusetts to the Townsend Public Library to fund Sunday hours during the winter months. SL seconded. Unanimous vote.
- 3.2 Set date for the Special Town Meeting, RE: Appropriation for feasibility study for roof repairs at Spaulding Memorial School.

Andrew Sheehan outlined the needed repairs for the Spaulding Memorial School; informing the Board a feasibility study would need to be done by an Architectural/Engineering firm. Mr. Sheehan relayed an estimated cost for the study is approximately \$40,000.00 and would need to be appropriated by a Special Town Meeting. NT moved to open the warrant for the Special Town Meeting to be scheduled on March 1, 2011. SL seconded. Unanimous vote.

- 3.3 Review/Sign Collective Bargaining Agreements for the Police & Highway Unions.
 - Mr. Sheehan explained the agreements have already been approved and signed and have been incorporated into the existing. NT moved to approve the collective bargaining agreements with the Police & Highway Unions and to sign the agreements outside of the meeting. SL seconded. Unanimous vote.
- 3.4 Review/Sign Intermunicipal Agreement for the Devens Regional Household Hazardous Products Collection Center.
 - The Board reviewed as attached. Mr. Sheehan explained only small changes have been made since the Board review a previous draft version. NT moved to review and sign the Intermunicipal Agreement for the Devens Regional Household Hazardous Products Collection Center outside of the meeting. SL seconded. Unanimous vote.
