SELECTMEN'S MEETING MINUTES FEBRUARY 14, 2012 - 7:00 P.M. SELECTMEN'S MEETING CHAMBERS

I PRELIMINARIES

- 1.1 The meeting was called to order at 7:03P.M.
- 1.2 Roll call vote showed 3 members present: Chairman Robert Plamondon, Vice-Chair Sue Lisio, Clerk Nicholas Thalheimer (NT).
- 1.3 Notice that the meeting is being tape recorded.
- 1.4 RP added 3.8 Contract for Water Department

II APPOINTMENTS / HEARINGS

2.1 Andrew Shepherd, RE: Eagle Scout Project.

Andrew Shepherd met with the Board and presented his proposed Eagle Scout project. The project proposal included building a memorial at the Townsend Police Station with a cobblestone patio and walkway with a bronze statue of a police officer. Mr. Shepherd explained the proposed project is being planned in conjunction with the Police Chief and hoped the memorial could include a piece of metal from the 911 twin towers. Mr. Shepherd asked the Selectmen to send a letter to Port Authority of NY to request that the town be granted a piece of the tower for placement in the project. NT moved to approve a letter and authorize Andrew Sheehan to sign on behalf of the Board of Selectmen. SL seconded. Unanimous vote.

- 2.2 Sue Funaiole, Town Clerk RE: Announcement of Dog Tag Contest Winner.
 - The Congdon family and their dog Nashoba was announced as the winner for the #1 Dog tag contest. Ms. Funaiole presented the family with the prizes that included area businesses gift certificates.
- 2.3 Don Klein, Fire-EMS Chief:
 - Vacancy posting process. Votes may be taken.
 - Boy Scout Venture Crew. Votes may be taken.

Fire-EMS Chief Don Klein asked the Board to agree to permanent vacancy postings for all oncall FIRE-EMS personnel. Mr. Sheehan relayed Town Counsel was consulted on the issue and the charter did not prevent such a posting. Ms. Funaiole, Town Clerk inquired to the procedure that is outlined in the Personnel Polices indicating a date for the applications to be filed. Mr. Sheehan suggested the posting include language that would read "until filled". NT moved to post vacancies on a permanent basis with wording that reflects until filled. SL seconded. Unanimous vote. Tom Whittier met with the Board and explained the Venture Crew program sponsored by the Boy Scouts of America. Mr. Whittier stated the crew would be chartered by the Firefighter's Association and be insured by the Boy Scouts. The Board reviewed the proposal – see attached. Mr. Whittier asked the Board for their support and recognition of the program. Andrew Sheehan suggested a motion to support the partnership between the scouts and the Fire Department in relation to the Venture Crew. NT so moved, SL seconded. Unanimous vote.
