August 14, 2017, at 6:30PM Townsend Memorial Hall, in Selectmen's Chambers 272 Main Street, Townsend, MA 01469

1 PRELIMINARIES:

- 1.1 Call the meeting to order: Lance McNally called the meeting to order at 6:30PM
- 1.2 Roll call: Lance McNally, Ed Howard, Kathy Araujo, Chris Nocella, and Jerrilyn Bozicas.

 - C. Nocella moved to approve Jerrilyn Bozicas as an alternate to the Planning Board. E. Howard seconded. All in Favor (AIF).

 - J. Mullen shared some of the changes he noticed in the town since he had helped with the 2001 Master Plan. Implementation of the recommendations from the next Master Plan are important. We need to consider how to market the plan to the community. Getting a diverse group of people involved J. Mullen had some suggestions such as offering meetings at different times and locations or in neighborhoods around churches or schools.

They could run the citizen participation portion and market research including what to put in the ads, infomercials, mailings, etc.

We need to assess what resources we currently have such as MRPC who can help with parts of the plan as well.
