## MEETING MINUTES February 1, 2012 at 7:00 p.m. Room 2

#### 1.0 Preliminaries

- **1.1 Call the meeting to order:** Chairman Cadogan opened the meeting at 7:03pm.
- **1.2 Roll Call:** Present were Members Tony Genova (TG), Julie Johnson (JJ), Bill Cadogan (BC), Darlene Sodano (DS) and Associate member John Giunta (JG). Also present was Administrative assistant Karen Chapman. Absent was member Craig Stevens and Associate member Kelly Chambers.

- **1.4 Review & approve minutes**: (12/14/11) DS motioned to approve the minutes of 12/14/2011. TG seconded the motion with all voting in favor.

2.1 Continuation of Public Hearing – Appeal – 39 Blood Road

BC reopened the public hearing at 7:04pm. JG recused himself from the discussion as he is an abutter. The applicant, Chad Falardeau (CF) was present. CF states he is trying to close on a house in Groton so he can move his business from Blood Road, but the bank refused financing. He is still going to buy the Groton house if he can, but in the meantime, he has a friend with commercial property to store his equipment. DS states the Board is at its time limit for making a decision, so it is at the Zoning Enforcement Officer's discretion for when the business must vacate 39 Blood Road. DS motioned to uphold the Building Commissioner's decision and findings in a letter dated 10/18/11 for the property at 39 Blood Road. JJ seconded the motion, with a roll call vote as follows: DS-yes, JJ-yes, TG-yes, BC-yes. The motion carried.
