 2.1 6:00pm: Continuation - 460 Main Street – Earth Excavation Permit The applicant is requesting a Special Permit to remove 82 yards³ of material. DS moved to reopen the Public Hearing. CS seconded. AIF. WC read the legal notice.

D. Application

H. The applicant shall operate all excavation only during the hours of 8:00AM and 4:30PM, Monday through Friday.

I. Standards

- (1) The Board waives this requirement due to lot size.
