**MOTION** By Harbor Committee Mel Atherton to include a map of Bass Harbor, seconded by Harbor Committee member George Lawson. All in favor 5-0.

### **C. REQUEST FROM RESIDENT TO DISCUSS FLOAT**

More discussion regarding temporary moorings,

**MOTION** by Harbor Committee member Mel Atherton to recommend that Harbor Master Greg Dow be granted permission to place 4 “temporary” moorings in Seal Cove, seconded by Harbor Committee member Art Paine. YES-3 NO-1 ABSTAIN-2.

Dean feels that they are over stepping the boundaries of the ordinance, even though it clearly states moorings are at the discretion of the Harbor Master.

Richard Helmke was present to discuss floats.
