

# THE TREMONT PLANNING BOARD HELD THE FOLLOWING PUBLIC HEARINGS 6:00 PM TUESDAY, APRIL 14th, 2009 IN THE TREMONT TOWN OFFICE MEETING ROOM

Chairman George Urbanneck opened the Public Hearings at 6:00 PM.

Public Hearing #1: To receive public input concerning proposed amendments to the Tremont Zoning Ordinance recently mandated by State Law regarding Shoreland Zoning.

Chairman George Urbanneck asked if anyone had any comments or questions concerning the State Mandated changes to the Tremont Zoning Ordinance. There were none.

**MOTION** by Planning Board member Linda Graham to close first Public Hearing, seconded by Planning Board member Susan Snyder. Motion passed 7-0.

Public Hearing #2: To receive public input concerning a proposed amendment to the Tremont Zoning Ordinance adding outdoor lighting to the "Performance Standards" section.

Peter Lord gave a presentation of night sky pollution. Chairman George Urbanneck asked if anyone had any comments or concerns. Deputy CEO Carl Young told the Board that he received an e-mail from a resident in support of the proposed lighting ordinance amendment (see attached). Some residents expressed concerns about the recommended best practices portion and some of the wordage in the proposed amendment itself.

## B. Action on Public Hearing #2

**MOTION** by Planning Board member Mike Ryan to postpone proposed Lighting Ordinance amendment until November, seconded by Planning Board member Susan Snyder.

Planning Board member Mike Ryan withdrew his motion and Planning Board member Susan Snyder withdrew her second.

**MOTION** by Planning Board member Mike Ryan to present Lighting Ordinance amendment at Town Meeting with amendments to add "or equal to" after greater than under requirements number 1, add "to article 2. requirements above" to number 3, exceptions, and place Recommended best practices as a note, seconded by Planning Board member Linda Graham. Motion passed 7-0.

C. Mandatory changes to Zoning Ordinance Map

Deputy CEO Carl Young explained that the Zoning Maps need to be updated to meet the State mandated laws and the State has given the Town until November 2009. If the Town Doesn't update the maps the State will impose a map on the Town.

#### 8. CEO ISSUES

A. Code Officer's request to review current commercial / industrial use at Map 2 Lot 2 at Bass Harbor, regarding the need for additional permitting.

Residents expressed concerns about rock crusher at Doug Gott & Sons gravel pit in Bass Harbor. Deputy CEO Carl Young explained that he has made two visits to the site and the rock crusher is a legal conforming use and saw no activities that are in violation of the Town of Tremont's Ordinance. Owners Doug and Timothy Gott discussed residents concerns with them.

Planning Board noted that this is a CEO Issue and not a Planning Board issue but were in general agreement that the current activities at the location did not constitute a change of use.
