B. Review the Board's Findings of Fact regarding the approval, on March 23 rd, of a Building Permit Application submitted by Robert & Judy Cousins to expand their living room with solar windows and add a dustpan to their residence and business located at 45 Harbor Dr.

Planning Board reviewed Findings of Fact and decided that "Mr. Cousins stated that greenhouse addition exterior walls will follow original plan" should be added.
