## TOWN OF TREMONT REGULAR SELECTMEN'S MEETING TREMONT COMMUNITY BUILDING MONDAY JUNE 6, 2005 6:00 PM

## 1. CALL TO ORDER

Acting Chairman Steve Harper called the Monday, June 6, 2005, Selectmen's Meeting to order at 6:03 PM.

## 2. ROLL CALL

Present were Acting Chairman Steve Harper, Selectmen Kathi Thurston, Heath Higgins, and Charlie Dillon, Town Manager Millard Billings and Recording Secretary Debbi Nickerson. Members of the public present were Beth Lawson, Andrew McMullan, Jennie Gray, Judy Cousins, Bob Cousins, Laurie Schreiber – Bar Harbor Times, Chad Smith – Town Attorney, James Collier – Town Attorney, Erick White, Mel Atherton, Peter Butler, Mark Good – Islander, Wayne Libhart, George Urbanneck, Brad Reed, and David Campbell.

## 3. ADJUSTMENTS/ADOPTION OF AGENDA

Town Manager Billings introduced three petitions that have been submitted to the Town Office. Town Manager Billings read, "We the undersigned registered voters of the Town of Tremont petition its Board of Selectmen to call a special town meeting for the purpose of authorizing the Selectmen to borrow a sum of money not to exceed Seventy-five thousand dollars for the purpose of restructuring the Seal Cove Fire Station building to accommodate the fire engines and equipment needed for that part of town." This petition is signed by 90 registered voters. He then read the other two petitions, "To the Municipal Officers of the Town of Tremont, We the undersigned, being registered voters of the Town of Tremont, request the municipal officers to place the following article before the voters for their consideration. A Petition to deny the proposed 300 foot pier on the basis of irreparable change to the Seal Cove Shoreline (Subdivision Ordinance of the Town of Tremont, Section H.B.9.) To the Municipal Officers of the Town of Tremont, We the undersigned, being registered voters of the Town of Tremont, request the municipal officers to place the following article before the voters for their consideration. A Petition to deny the proposed Subdivision on the Seal Cove Shore on the basis of excessive traffic, which will be generated by such a Subdivision that cannot be handled by the existing Cape Road (Subdivision Ordinance of the Town of Tremont, Section H.B.8.)" These two were signed by 58 and 64 registered voters. Acting Chairman Harper asked, "We don't have to act on this tonight?" Town Manager Billings said they didn't have to act on them tonight and he suggested the petitions be turned over to the Town's Attorney. Acting Chairman Harper asked if anyone was at the Selectmen Meeting to speak on any of the petitions. Wayne Libhart said, "I'm the guy that started the Fire Station Petition. I would hope you act tonight, but I wouldn't expect it. There is a certain amount of urgency involved, if the town's going to do it, it needs to be done sooner

rather then later. And to call a Special Town Meeting you've got to do the proper notices, so there's a build in delay there of at least a month. I think this petition shows the interest in the town in having this done. I think there are more signatures there then were at the Town Meeting, and it was clear to all of us at the Town Meeting that had that come up for a vote to raise money for the project it would have passed without any question. So my purpose is to present it to you and hope that you will act on it in the very near future." Acting Chairman Harper said, "We will submit all three of these to our Town's Attorney for review." Mr. Libhart agreed. Fire Chief Brad Reed volunteered his salary from this year to pay for the Special Town Meeting. Town Manager Billings suggested the Town get a loan for both Fire Stations that need work and the dredging project in the harbor.

**Motion** made by Selectman Heath Higgins, with second by Selectman Charlie Dillon, to hold a Special Town Meeting for the Fire Department. Motion passed by a show of hands 4-0.

**Motion** made by Selectman Charlie Dillon, with second by Selectman Heath Higgins, to refer the petitions for the pier and proposed sub-division to the Town Attorney for review and advice. Motion passed by a show of hands 4-0.

#### 4. APPROVAL OF MINUTES

**Motion** made by Selectman Charlie Dillon, with second by Selectman Heath Higgins, to accept the minutes of May 16<sup>th</sup>. Motion passed by a show of hands 4-0.

**Motion** made by Selectman Charlie Dillon, with second by Selectman Heath Higgins, that the Board go into Executive Session pursuant to Title 1 M.R.S.A. § 405 (6) (E) to consult with the Town Attorney on Rule 80K. Motion passed by a show of hands 4-0. The Selectmen went into Executive Session at 6:30 PM.

**Motion** made by Selectman Charlie Dillon, with second by Selectman Heath Higgins, the Selectmen came out of Executive Session. Motion passed by a show of hands 4-0. The Selectmen came out of Executive Session at 7:10 PM.

C. AGENDA ITEM 6. D. APPLICATION FOR FIRST TIME LIQUOR LICENSE **Motion** made by Acting Chairman Steve Harper, with second by Selectman Charlie Dillon, to move to Agenda Item 6. D. Motion passed by a show of hands 4-0.

**Motion** made by Selectman Charlie Dillon, with second by Selectman Heath Higgins, to have a Public Hearing on June 20, 2005 for a new on-premise Liquor License submitted by Robert & Judy Cousins for "Cap'n Nemo's" located at the intersection of Flat Iron Rd. and Route 102A in Bass Harbor. Motion passed by a show of hands 4-0. Selectman Heath Higgins asked the Cousins to include a floor plan of the area where liquor will be consumed with the final application.

D. AGENDA ITEM 6. H. REC BOARD FOR SCHOLARSHIP AND TRAIL **Motion** made by Acting Chairman Steve Harper, with second by Selectman Heath Higgins, to skip to H. Motion passed by a show of hands 4-0. Rec Board Member Beth Lawson said, "Heidi came here about the scholarships and the walking trail and we were told to get information from MMA. I called and talked to Bill Livingood regarding the legal issues involved in the Rec Board developing a scholarship fund for children in our community to attend summer camp programs. Mr. Livingood recommended that we include a waiver to release the board from being legally liable for injury or events that could occur at camp. The waiver also needs to include that the board in no way influenced the parents or child in which camp to attend. He also suggested getting a way from any religion or political type camp. . . And then he suggested to have the Town's insurance agent review the application, which we have done. . . So we revamped our guide lines for the summer camp scholarships to include what type of scholarships are available," (see attached). Rec Board Member Andrew McMullen explained, "We debated whether to go with a dollar amount of a percent amount. . . We thought we'd just go with a monetary amount. . . We will look at need and use our discretion and be very confidential about it." Motion made by Selectman Charlie Dillon, with second by Selectman Heath Higgins, to approve the Rec Board's request of May 26<sup>th</sup> for scholarships, walking trail and Backside Blast. Motion passed by a show of hands 4-0.

F. AGENDA ITEM 6. E. AWARD CONTRACT FOR TOWN LINE SURVEY Town Manager Millard Billings said, "Bids were opened on May 23<sup>rd</sup> at 4:00. There was only one bid. . . CES submitted a bid for \$6,800."

Motion made by Selectman Charlie Dillon, with second by Selectman Kathi Thurston, to award the bid for the Town Line Surveying to CES for \$6,800. Motion passed by a show of hands 4-0.

## G. AGENDA ITEM 6. F. CEMETERY MOWING

Town Manager Millard Billings told the Selectmen, "The bids closed this afternoon at 4:00. At 4:01 the bids were opened. There were 3 bids submitted." Selectman Heath Higgins asked, "Did any suggest a Bond or Insurance Policy with any of these applications?"

**Motion** made by Selectman Charlie Dillon, with second by Selectman Heath Higgins, to give the contract for the Cemetery to Rita Baldwin for \$20.00 an hour. Motion passed by a show of hands 4-0.

## H. AGENDA ITEM 6. G. PROCEED WITH BIDS FOR ROAD WORK CAPE & TURNER

Town Manager Millard Billings said, "The blasting has been completed on the Cape and Turner Rd. Now we look forward to getting the ledge from the Town

Office site and use that as rip-rap in those ditches and then get the foundation and the rock cleaned out for the Town Office." Selectman Charlie Dillon asked, "Did you send this to local contractors?" Town Manager Billings replied, "The ad is in the paper. Gott's and Goodwin's got copies and a copy was mailed to McQuin's."

### 8. TOWN MANAGER'S REPORT

Town Manager Billings said, "There was an administrative appeal filed with the Board of Appeals by Art Paine about a permit issued by the CEO - that has since been withdrawn by the plaintiff as a result of negotiations. There is correspondence in your packet from the Southwest Harbor Town Manager regarding proposed road work on Routes 102 and 102A. He would like for the Southwest Harbor Selectmen and the Tremont Selectmen to have a joint meeting and see what they can do. . . In your handouts tonight there is an e-mail I received that tells us the Governor did sign the Cemetery Bill. And to thank the Town and the Cemetery Committee for bringing this bill forward. . . 102 is scheduled to have some resurfacing done next year. It seems the road has major structural problems and is in need of major rebuilding. However the DOT says that part of 102 through Tremont is a minor collector. For major work to be done the Town needs to send a formal request to the State for work, and the Town needs to pay 1/3 of the costs." Selectman Dillon suggested signing on with Southwest Harbor, "and see if we can't get something done with 102." Selectman Dillon said, "I'd be interested in finding out if Mt. Desert or Bar Harbor paid for those repairs on Indian Point and Long Pond extensions last year and the year before." He then asked Town Manager Millard Billings to check in to that. Town Manager Millard Billings went on to say, "The Harbor Committee met on May 25<sup>th</sup> and they recommended ending the Harbormaster search as of June 7. The Harbor Committee with review the applications on June 8<sup>th</sup> and interview their selected candidates on June 15<sup>th</sup>. And the Harbor Committee recommendations for Harbormaster submitted to the Board of Selectmen for their meeting on June 20<sup>th</sup>." He went on to point out there was a copy of the Contract between Hancock County Commissioners and the Town of Tremont for Sheriff coverage in their packets.

## 9. SUGGESTIONS/COMMENTS FOR NEXT MEETING

Selectman Dillon said, "Next meeting we will have to have election of officers."

#### 10. OTHER

**Motion** made by Selectman Charlie Dillon, with second by Selectman Heath Higgins, I move that the Selectmen direct the Town Manager to instruct the Town Attorneys to take any and all actions and legal proceedings necessary to effectuate compliance by Donald Murphy and any other owner or party having an interest in property formerly owned by Eldora Murphy, or other person, with any and all ordinances and laws that are under the jurisdictional authority of the Town, including but not limited to

compliance with the State of Maine Junkyard Law (30-A M.R.S.A. § 3751 et seq.) and the Tremont Zonings Ordinances. Motion passed by a show of hands 4-0.

Acting Chairman Steve Harper suggested swapping the dump truck's body for a low ride. Town Manager Billings replied, "If the idea down the road is to get a bigger backhoe the size of the truck wouldn't be an issue."
