# 5. APPROVAL OF WARRANTS

# 6. NEW BUSINESS

# A. ACTION ON SNOWPLOW BIDS

Bid packets were opened at 4:00 pm on March 20, 2006. Two bids were received – Doug Gott and Sons, \$365,000.00 and John Goodwin Jr., \$510,000.00. Doug Gott and Sons bid was incomplete.

**Motion** made by Selectman Kathi Thurston, with second by Selectman Heath Higgins, to table for the Town Manager to contact either MMA or the Town Attorney for more information. Motion passed by a voice vote 3-0.

#### B. UPDATE NEW TOWN OFFICE

Ads have been submitted to the Bar Harbor Times and Mount Desert Islander to run for three weeks and the Bangor Daily News to run in two weekend editions, for the construction of the Town Office Building.

Steve Wilson, Clerk of the Works for the Office Project, updated the Selectmen on the project.

The Selectmen are concerned there is not enough money for the new Town Office and decided to put an Article in the Warrant for Town Meeting with no dollar amount.

# C. TOWN LINE SURVEY

Mike Avery has submitted a copy of an amended Surveyor's Report as sent to Plisga & Day. The second paragraph of page 4 of 5 has been amended to revise and clarify a statement about the deed recorded in Book 1147 Page 382 (see attached). Town Manager Millard Billings has spoken to Knuit Hermanson, a renowned authority on survey law, who has agreed to review the documents. **Motion** made by Selectman Heath Higgins, with second by Selectman Kathi Thurston, to accept his revised report from CES, March 13, 2006, from Mike Avery with CES. Motion passed by a voice vote 3-0.

# D. RELEASE DEED

Municipal Quitclaim Deed for Conconino Equipment & Investment, Inc. (see attached).

**Motion** made by Selectman Kathi Thurston, with second by Selectman Heath Higgins, to sign the Municipal Quitclaim Deed without covenant for Conconino Equipment & Investment, Inc. Motion passed by a voice vote 3-0.

**Motion** made by Selectman Heath Higgins, with second by Selectman Kathi Thurston, to recommend \$6,000.00 for General Assistance. Motion passed by a voice vote 3-0.

**Motion** made by Selectman Heath Higgins, with second by Selectman Kathi Thurston, to recommend \$500.00 for Seal Cove Fishway. Motion passed by a voice vote 3-0.

**Motion** made by Selectman Heath Higgins, with second by Selectman Kathi Thurston, to recommend \$94,200.00 for EMR Solid Waste. Motion passed by a voice vote 3-0.

**Motion** made by Selectman Heath Higgins, with second by Selectman Kathi Thurston, to recommend \$58,400.00 for PERC Solid Waste. Motion passed by a voice vote 3-0.

Selectman Kathi Thurston asked what is a safe amount to remove from surplus. It was decided to invite the auditors to the March 27, 2006 Selectman Meeting.
